RE-DETERMINATION **OF THE** BOUNDARIES **OF** CROSS-BOUNDARY MUNICIPALITIES AMENDMENT BILL, **2005**

BILL

To authorise the re-determination **of** the boundaries **of** certain cross-boundary municipalities; **to** amend the Local Government: Cross-boundary Municipalities Act, **2000**; and to provide **for** matters connected therewith.

PREAMBLE

WHEREAS the re-determination of cross-boundary municipalities should be authorised with the concurrence of the legislatures of the provinces involved;

AND **WHEREAS** the re-determination of cross-boundary municipalities should be authorised by national legislation;

NOW BE IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows: -

Authorisation **of** re-determination **of** boundaries **of** cross-boundary municipalities

1. Subject to section 2(a) of the Local Government: Cross-boundary Municipalities Act, 2000 (Act No. **29** of **2000**), the re-determination of the boundaries of the municipalities referred to in the Schedule, is hereby authorised.

Amendment of Act 29 of 2000, as amended by section 2 of Act 69 of 2000

MEMORANDUM ON THE OBJECTS OF THE RE-DETERMINATION OF THE BOUNDARIES OF CROSS-BOUNDARY MUNICIPALITIES AMENDMENT BILL, 2005

- **1.** Section 2 of the Local Government: Cross-boundary Municipalities Act, 2000 (Act No. 29 of 2000) ("the Act"), authorises the re-determination of the boundaries of cross-boundary municipalities-
 - (a) with the concurrence of the legislatures of the provinces involved; and
 - (b) if the re-determination is authorised by national legislation.
- 2. The purpose of the Bill is to authorise the re-determination of the boundaries of certain cross-boundary municipalities in accordance with section 2(b) of the Act. Irrespective of what decision is taken regarding the future of cross-boundary municipalities, these authorisations must be attended to in view thereof that the proposed boundary re-determinations have been taken into account for purposes of the ward delimitation process. The proposed re-determinations are set out hereunder.

3. MPUMALANGA AND GAUTENG

3.1 CHANGE TO BOUNDARY OF CBLC2

The municipal boundaries of Thembisile Local Municipality (MP315), Nkangala District Municipality (DC31), Kungwini Local Municipality (CBLC2) and Metsweding District Municipality (CBDC2) are re-determined by including the farms Rooipoort (440JR), Vlakfontein (453JR) and Vaalplaas (463JR) comprising of the traditional authority of Sokhulumi into the municipal area of Kungwini (CBLC2) and Metsweding (CBDC2) and by excluding the area from the municipal areas of Thembisile (MP315) and Nkangala (DC31).

The municipal boundaries of Ekurhuleni Metropolitan Municipality, Kungwini Local Municipality (CBLC2) and Metsweding District Municipality (CBDC2) are re-determined by aligning the current municipal boundary to Surveyor General cadastre affecting portions of the farm Tweefontein.

3.2 CHANGE TO BOUNDARY OF CBDC2 (SEE ALSO CBLC2)

The municipal boundaries of City of Tshwane Metropolitan Municipality, Nokeng Tsa Taemane Local Municipality (GT02b1) and Metsweding District Municipality (CBDC2) are re-determined by excluding Portions 4, 22 and 23 of the farm Doornpoort No. 295 JR, a Portion of the farm Haakdoornlaagte No. 277 JR and a Portion of the farm Pylpunt No. 276 JR from the municipal area of Tshwane and by including the areas in the municipal areas of Nokeng Tsa Taemane (GT02b1) and Metsweding District Municipality (CBDC2).

The municipal boundaries of City of Tshwane Metropolitan Municipality, Nokeng Tsa Taemane Local Municipality (GT02b1) and Metsweding District Municipality (CBDC2) are re-determined by aligning the current municipal boundary to the southern boundary of Stanza Bopape settlement.

3.3 CHANGE TO BOUNDARY OF EKURHULENI METROPOLITAN MUNICIPALITY (SEE ALSO CBLC2)

The municipal boundaries of City of Johannesburg Metropolitan Municipality and Ekurhuleni Metropolitan Municipality are re-determined by excluding the township Commercial Extension 9 from the municipal area of City of Johannesburg Metropolitan Municipality and by including the mentioned extension in the municipal area of Ekurhuleni Metropolitan Municipality and by aligning the current municipal boundary to the Surveyor General cadastre affecting portion 38 of Erf no. 107 Elandspark, portions of the Farm 35 and portions of Farm 15 and Farm 1.

4. MPUMALANGA AND LIMPOPO

4.1 CHANGE TO BOUNDARY OF CBLC4 AND CBDC3

The municipal boundaries of Thembisile Local Municipality (MP315), Greater Groblersdal Local Municipality (CBLC4), Sekhukune District Municipality (CBDC3) and Nkangala District Municipality (DC31) are re-determined by excluding the farm Vreemdeling No. 65 **JS** from the area of Thembisile (MP315) and Nkangala (DC31) and including it into the municipal area **of** Greater Groblersdal (CBLC4) and Sekhukune (CBDC3).

The municipal boundaries of Greater Tubatse Local Municipality (CBLCS) and Greater Groblersdal Local Municipality (CBLC4) are re-determined by aligning the current municipal boundary to Surveyor General cadastre affecting the settlement north of Lakau.

4.2 CHANGE TO BOUNDARY OF CBLCS (SEE ALSO CBLC4)

The municipal boundaries of Fetakgomo Local Municipality (NP03A3) and Greater Tubatse Local Municipality (CBLCS) are re-determined to align the current municipal boundary to Surveyor General cadastre affecting portions of the farm Quartzhill.

5. NORTH WEST AND NORTHERN CAPE

5.1 CHANGE TO BOUNDARY OF CBDCI

The municipal boundaries of Kagisano Local Municipality (NW391), Bophirima District Municipality (DC39), Moshaweng Local Municipality (NWIaI) and Kgalagadi District Municipality (CBDCI) are re-determined by including Bagabareki TA as well as farms Thurso 310 IL, Frome 317 IL, Shepton 322 IL

and Rockley 322 IL into the municipal area of Moshaweng Local Municipality (NW1a1) and Kgalagadi District Municipality (CBDCI).

The municipal boundaries of Tsansabane Local Municipality (NC085), Siyanda District Municipality (DC8), Gamagara Local Municipality (NCOIb1) and Kgalagadi District Municipality (CBDCI) are re-determined by excluding the Allotment Area of Olifantshoek from the municipal area of Tsantsabane (NC085) and Siyanda (DC8); excluding the farms Hartley No. 573, Cox No. 571 and Murray No. 570 (forming part of the District Management Area NCDMA08) from the municipal area of Siyanda (DC8); and by including the Allotment Area and the mentioned farms in the municipal areas of Gamagara (NC01b1) and Kgalagadi (CBDCI).

5.2 CHANGE TO BOUNDARY OF DC9

The municipal boundaries of Kgatelopele Local Municipality (NC086), Siyanda District Municipality (DC8) and Frances Baard District Municipality (DC9) are redetermined by excluding an area comprising of farms from the municipal area of Kgatelopele (NC086) and Siyanda (DC8) and by including the area in the municipal area of Frances Baard (DC9) as part of the district management area NCDMA09.

6. NORTH WEST AND GAUTENG

6.1 CHANGE TO BOUNDARY OF CBDC8

The municipal boundaries of Emfuleni Local Municipality (GT421), Sedibeng District Municipality (DC42), Westonaria Local Municipality (GT414) and West Rand District Municipality (CBDC8) are re-determined by aligning the current municipal boundary to Surveyor General cadastre affecting portions of the farm Kalbasfontein.

The municipal boundaries of West Rand District Municipality (CBDC8) and Tshwane Metropolitan Municipality are re-determined by aligning the current municipal boundary to the outer boundaries of portions of the farms Rhenosterspruitand Riverside Estate.

6.2 CHANGE TO BOUNDARY OF TSHWANE METROPOLITAN MUNICIPALITY (SEE ALSO CBDC2)

The municipal boundaries of Moretele Local Municipality (NW371), Bojanala District Municipality (DC37) and City of Tshwane Metropolitan Municipality are redetermined by excluding a portion of Portion 8 of the farm Boschplaas 091 (JR), from the municipal area of Moretele Local Municipality (NW371) and Bojanala District Municipality (DC37) and by including the Portion in the municipal area of Tshwane Metropolitan Municipality.

The municipal boundaries of Tshwane Metropolitan Municipality, Madibeng Local Municipality (NW372) and Bojanala Platinum District Municipality (DC37) are redetermined by aligning the current municipal boundary to Surveyor General cadastre affecting Bakgatla Ba Mmakau **TA**.

The municipal boundaries of Tshwane Metropolitan Municipality, Moretele Local Municipality (NW371) and Bojanala Platinum District Municipality (DC37) are redetermined by aligning the current municipal boundary to the Surveyor General cadastre by incorporating a portion of Winterveld into the Tshwane Metropolitan Municipality and a portion of farm Kromkuil into Moretele Local Municipality (NW371).

9. IMPLICATIONS FOR PROVINCES

The concurrence of the legislatures of the provinces involved, is also required before the re-determination of boundaries can be finalised.

10. IMPLICATIONS FOR MUNICIPALITIES

The Bill has an impact on municipalities inso-faraschanges to the boundaries of cross-boundary municipalities will also affect neighbouring municipalities.

11. PARLIAMENTARY PROCEDURE

- 11.1 The State Law Advisers and the Department of Provincial and Local Government are of the opinion that this Bill must be dealt with in accordance with the procedure established by section 75 of the Constitution. The Bill does not fall within a functional area listed in Schedule 4 of the Constitution, nor does it provide for legislation envisaged in the sections referred to in section 76(3) of the Constitution.
- 11.2 The State Law Advisers are of the opinion that it is not necessary to refer this Bill to the National House of Traditional Leaders in terms of section 18(1)(a) of the Traditional Leadership and Governance Framework Act, 2003 (Act No.41 of 2003), since it does not contain provisions pertaining to customary law or customs of traditional communities.
