### **Explanatory Memorandum to the Municipal Allocations set out in Schedule 4**

This gazette is published in terms of the 2007 Division of Revenue Act (No. 1 of Act 2007) ("The Act") and provides information on adjustments and re-allocation of allocations to municipalities in the 2007/08 national financial year.

This gazette therefore updates information that was originally published in *Government Gazette* No. 29797 and 30592. The introductory information provided in these *Gazettes* therefore applies equally to this gazette, and is not repeated here.

Section 27 of the Act allows for the re-allocation of funds by the National Treasury due to persistent and material non-compliance with the provisions of this Act. Such re-allocation must together with an explanatory memorandum be published in the gazette as required by section 26(3) and (4).

This notice affects the following grant programme:

- R63.0 million is re-allocated from the Municipal Infrastructure Grant. Re-allocation is effected as a result of non-compliance due to significant under expenditure.
- The R63.0 million was unallocated during the national adjustment budget in December 2007.

Municipalities are requested to effect these adjustments to their projections of the grant income accordingly.
