#### NOTICE IN TERMS OF S62(7) OF THE LABOUR RELATIONS ACT 66 OF 1995

Interested and affected parties are advised that a demarcation dispute has been referred to the Commission for Conciliation, Mediation and Arbitration (hereinafter referred to as the CCMA) [reference HO94-08] and that the CCMA believes it to be a question of substantial importance, requiring the publication of this notice.

The present parties to the dispute are: **ADM Fitment Centre cc t/a Auto Den** (*Applicant*) and **Motor Industry Bargaining Council (MIBCO)** (*Respondent*).

The demarcation dispute arises from:

Whether the Applicant's business involving the selling and fitment of tracking devices to motor vehicles falls within the registered scope and jurisdiction of MIBCO and are therefore subject to the requirements and obligations in terms of the respective collective agreements.

The Applicant seeks that it be ruled that it does not fall within the jurisdiction of MIBCO and as a result are exempted from all collective agreements applicable in the motor industry from April 2005.
