

**NATIONAL REGULATOR FOR COMPULSORY SPECIFICATIONS ACT, ACT 5 OF 2008
REGULATIONS RELATING TO THE PAYMENT OF LEVY AND FEES WITH REGARD TO
COMPULSORY SPECIFICATIONS: AMENDMENT**

It is hereby made known under section 14. 3 (b) of the National Regulator for Compulsory Specifications Act, (Act 5 of 2008), that the Minister of Trade and Industry, hereby with effect from the date of publication in the Government Gazette, amends Schedule 2 of the Regulations published by Government Notice No. R. 999 of 3 May 1985 by the deletion of the existing tariffs for automotive products, and the substitution thereof with the tariffs set out in the attached schedule.
