AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Energy has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.

SCHEDULE

1. Definitions

In these regulations "the Regulations" mean the regulations published by Government Notices Nos. R.1317 of 2 December 2008, R.9 of 06 January 2009, R.108 of 3 February 2009 and R.245 of 3 March 2009 and R.389 of 31 March 2009, R.511 of 5 May 2009, R.639 of 2 June 2009, R.717 of 30 June 2009, R.823 of 4 August 2009, R.893 of 1 September 2009, R.970 of 6 October 2009 and R.1132 of 1 December 2009.
