AMENDMENTS AGREED TO

PARLIAMENTARY VILLAGES BOARD OF CONTROL BILL [B 103–98]

CLAUSE 1

1. On page 2, in line 5, to omit "Board of Control" and to substitute "Management Board".

CLAUSE 2

- 1. On page 2, in line 13, to omit "Board of Control" and to substitute "Management Board".
- 2 . On page 2, from line 17, to omit subparagraph (ii) and to substitute:
 - three residents, of whom two shall be parliamentarians and one shall be a sessional official, from every place of accommodation contemplated in the definition of "parliamentary villages", elected annually by the residents committee of the place in question; and
- \cdots 3. On" page 2; from "line 21, to omit paragraph (b).
 - 4. On page 2, from line 23, to omit subsection (3) and to substitute:
 - (3) (a) The first meeting of the Board shall be held at a time and place to be determined by the chairperson, and subsequent meetings "shall be held at such times and places as the chairperson with the approval of the Board may determine.
 - (b) The Board shall meet at least once every three months.
 - (4) The members of the Board shall at the first meeting of every newly constituted Board elect a vice-chairperson from their number.
 - (5) The Board shall frame rules governing its quorum, the procedure at meetings and, generally, the conduct of its functions, and may from time to time add to, alter or revoke any such rules.
 - (6) The Board may co-opt any person to serve on the Board in an advisory capacity, but such co-opted member shall not have any voting rights.

CLAUSE 3

- 1. On page 2, in line 32, to omit "in connection with a session of Parliament".
- 2. On page 2, after line 32, to insert the following paragraph:
 - (b) observe any tariff fixed by the Minister with the concurrence of the Minister of Finance and the Minister of Transport in respect of any service referred to in paragraph (a), and shall be subject to such directions as the Minister may issue after consultation with the Board; and

- 3. On page 2, from line 34, to omit subsection (2) and to substitute:
 - (2) The Board may—
 - (a) take the steps necessary. to provide for all the needs of the residents of the parliamentary villages; liaise with the South Africantolice Service regarding entry into
 - and safety in parliamentary villages and the investigation of crimes committed in parliamentary villages; and (c) make recommendations with regard to any matter contemplated
 - in paragraph (b) to the Minister for Safety and Security.
- On page 4, from line 8, to omit subsection (3).

CLAUSE 6

- On page 4. after line 32, to insert the following subsection: 1.
 - (2) Any activity carried on under section 28(2)(c) of the Finance and Financial Adjustments Acts Consolidation Act, 1977 (Act No. 11 of 1977), shall be continued until the Board has taken steps to provide for such an activity under this Act or has decided not to provide for such an activity.

CLAUSE 8

On page 4, in line 37, to omit "Board of Control" and to substitute "Management Board".

On page 2, in the second line, to omit "Board of Control" and to substitute "Management Board".
