# BILL

**To effect adjustments to the appropriation of money from the National Revenue Fund for the requirements of the State in respect of the 2012/2013 financial year; and to provide for matters incidental thereto.**

## PREAMBLE

**WHEREAS** section 213(2) of the Constitution of the Republic of South Africa, 1996, provides that money may be withdrawn from the National Revenue Fund only in terms of an appropriation by an Act of Parliament;

**WHEREAS** the Appropriation Act, 2012 (Act No. 7 of 2012), provides for the appropriation of money from the National Revenue Fund to provide for the requirements of the State in respect of the 2012/2013 financial year;

**AND WHEREAS** section 12(1) and (2) of the Money Bills Amendment Procedure and Related Matters Act, 2009 (Act No. 9 of 2009), provides for the tabling of a national adjustments budget, as envisaged in section 30 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), and an adjustments appropriation Bill, to make adjustments to the appropriations in an Appropriation Act,

**B**E IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

### Interpretation

**1.** In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Appropriation Act, 2012 (Act No. 7 of 2012), or the Public Finance Management Act, 1999 (Act No. 1 of 1999), has the meaning assigned to it in those Acts. 5

### Adjustments to appropriations of money for requirements of State

**2.** (1) Adjustments to appropriations by Parliament of money from the National Revenue Fund for the requirements of the State for the 2012/2013 financial year to votes and main divisions within a vote, and amendments to the aims and purposes specified, are set out in Schedule 2 to this Act. 10

(2) The spending of appropriations contemplated in subsection (1) is subject to the Public Finance Management Act.

### Appropriation listed as specifically and exclusively 15

**3.** An appropriation to a vote or main division within a vote that is listed as specifically and exclusively appropriated in Schedule 2 to this Act may only be utilised for the purpose indicated, unless an Act of Parliament amends the purpose for which it was allocated.

### Conditional expenditure

4. (1) The Minister may—
- (a) impose conditions in respect of an appropriation in Schedule 2 to this Act, in order to promote and enforce transparency and effective management in respect of revenue, expenditure, assets and liabilities of departments, public entities and constitutional institutions in terms of section 6(1)(g) of the Public Finance Management Act; and 5
  - (b) stop any allocation in terms of such an appropriation until any condition imposed by the Minister is met.
- (2) The stoppage of an allocation in terms of subsection (1)(b) must be included in the National Treasury's next quarterly report to the Standing Committee on Appropriations of the National Assembly and the Select Committee on Appropriations of the National Council of Provinces. 10

### Utilisation of saving

5. (1) Despite section 43(4)(b) and (c) of the Public Finance Management Act, and in order to expedite service delivery, the Minister may approve the utilisation of a saving in an amount appropriated for— 15
- (a) transfer to another organ of state or to an organisation or body outside of government, for the same purpose as that of the main division within the vote in which it was originally appropriated; and 20
  - (b) payments for capital assets, in the same vote for other categories of expenditure, other than for the compensation of employees.
- (2) The approval of the utilisation of a saving in terms of subsection (1) must be reported in the National Treasury's next quarterly report to the Standing Committee on Appropriations of the National Assembly and the Select Committee on Appropriations 25 of the National Council of Provinces.

### Allocations for and expenditure by departments whose allocations are included in same budget vote

6. (1) The votes listed in column 1 of Schedule 1 to this Act contain the allocations for departments listed in column 2 of that Schedule. 30
- (2) Departments listed in column 2 of Schedule 1 to this Act, whose allocations are included in the same budget vote, must comply with the requirements in section 7 of the Appropriation Act, 2012 (Act No. 7 of 2012).

### Regulations

7. The Minister may, by notice in the *Gazette*, make regulations regarding any ancillary or incidental administrative or procedural matter that it is necessary to prescribe for the proper implementation or administration of this Act. 35

### Short title

8. This Act is called the Adjustments Appropriation Act, 2012.
