

MAGISTRATES' COURTS ACT 1944 (ACT NO. 32 OF 1944): ANNEXURE OF CERTAIN DISTRICTS TO THE REGIONAL COURT IN RESPECT OF OFFENCES COMMITTED WITHIN THE RUSTENBURG AREA

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, under section 2(1)(e), 2(1) (g) (i) and (ii), 2(1) (iA) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) (Magistrates' Court Act), as amended hereby –

- (a) annex, until further notice and for purposes of allowing the removal of asbestos and its debris to be removed from the seat of the district in Rustenburg, the Rustenburg magisterial district as described in the accompanying Schedule, to the sub-district of Tlhabane with its seat in Tlhabane for the purpose of -
 - (i) the trial of persons accused of committing any offences which shall have jurisdiction contemplated in section 89 and 92 of the Magistrates' Court Act, 1944; and
 - (ii) adjudication of civil disputes contemplated in section 29(1) or 29 (1B) or 29 (1) and (1B) of the Magistrates' Court Act, 1944; and
- (b) appoint the Rustenburg municipal licencing department situated at Geelhout as a place for the holding of a detached court of Tlhabane; and
- (c) appoint Tlhabane, within the North West regional division for the holding of a court for the adjudication of civil disputes in respect of the magisterial districts of Kgetlengrivier (and Swartruggens Sub-district) and Rustenburg (and Tlhabane Sub-district) contemplated in-
 - (i) section 29 (1); or
 - (ii) section 29 (1B); or
 - (iii) section 29(1) and (1B).

SCHEDULE

Rustenburg Main Seat	Local limits defined by point-to-point description
	<p>Starting on the north west beacon of the Magaliesberg Nature Reserve B, proceed in an easterly direction then a southerly direction and then an easterly direction until it intersects with the R565 road. Then proceed southerly along the R565 which merges onto the N4 motorway continue past the merger until the north eastern boundary of the Magaliesberg Nature Reserve B. Then proceed in a north-easterly direction until the south east beacon of the Wildbeefontein Mine. From there, proceed in a southerly direction then a north easterly direction until it intersects with the R510 road. Proceed in a north easterly direction along the R510 road until the Thlabane SAPS, then in a easterly direction, then a south westerly direction until the north east beacon of the farm Paardekraal No.279. From there proceed in a north easterly direction then a northerly direction and then a north easterly until it intersects with the Madibeng Magisterial District boundary. Then proceed along the western boundary in a southerly direction, then a south westerly direction, then a south easterly direction until it intersects with Tlapa A township. From there, proceed in a north easterly until the Maamong school. Then proceed in a south easterly direction until it intersects with the south west beacon of the farm Pearl No.401. Then proceed in a south westerly direction until you intersect with the north east beacon of the farm Zwartkoppies No.296. Then proceed in a southerly direction along the eastern boundaries of the farms Zwartkoppies and Rooikoppies No.297 until it intersects with the northern boundary of the farm Kafferskraal No.342, then continue to the north east beacon thereof. From there, proceed in a southerly direction along the eastern boundary of Kafferskraal No.342, and until the south east beacon of Buffelsfontein No.344. Then proceed in a southerly direction until the northern western boundary of the Gauteng Provincial boundary. Then proceed in a westerly direction until it intersects with the north west beacon of the farm Doornhoek No.392. Then in a southerly zig-zag direction along the western boundary of Doornhoek, Doornkloof Agricultural Holdings, and NewThorndale Agricultural Holdings until it intersects with the north western part of Rietpoort A.H. Then proceed in a westerly direction until the intersection of the northwest beacon of the farm Cyferfontein No.35. Then along the southern boundary of the Rustenburg Magisterial and Kgetlengrivier Magisterial boundary proceed in a northerly direction then a north westerly direction, then a northerly direction, then a westerly direction then a northerly direction until it intersects with the R30 road as it will further appear on the map. From the R30 road, proceed in a north westerly direction, then a northerly direction until it intersects with the south west beacon of the Magaliesberg Nature reserve. Then proceed in a north easterly direction until it intersects with the western boundary of the farm Rustenburg Nature Reserve. Then proceed in a northerly direction until the south west beacon of Magaliesberg Nature Reserve B. Then proceed in a north westerly direction to the northwest beacon of Magaliesberg Nature Reserve B, which is the starting point.</p>
