# APPLICATION FOR AMENDMENT OF RADIO FREQUENCY SPECTRUM LICENCE BY RHYTHM FM

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from Rhythm FM, for the amendment of its Radio Frequency Spectrum (RFS) Licence lodged in terms of the provision of section 31 (4) of the Electronic Communications Act, No. 36 of 2005 (ECA) read with Regulation 9 of the Radio Spectrum Frequency Regulations, notice 597 of 2015 as published in Government Gazette No. 38641. Rhythm FM seeks to add eleven (11) transmitters within its licensed area of the Eastern Cape Province. The proposed additional transmitters will be located at Aliwal North, Butterworth, Cradock, Graaff-Reinet, Kareedouw, King Williams Town, Noupoort, Port Elizabeth, Port St Johns, Queenstown and Umtata.
