DEFINITIONS

Regulation 4, Sub regulation 4B(Id): is hereby amended by -

- 1. Deletion of:
 - (a) Learners offering Physical Sciences [and Accounting] as one [or more] of their optional subjects selected from Group B in the policy document, National policy Pertaining to the Programme and Promotion Requirements of the National Curriculum Statement Grades R 12; must offer Mathematics as a compulsory subject selected from Group A in the said policy document.
