DELEGATIONS OF POWERS, ASSIGNMENT OF FUNCTIONS AND ALLOCATION OF RESPONSIBILITIES TO THE DEPUTY MINISTER OF JUSTICE AND CORRECTIONAL SERVICES

In accordance with the powers and functions assigned to me by the President in terms of section 92(2) of the Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996), which reads:

"The President appoints the Deputy President and Ministers, assigns their powers and functions and may dismiss them"

I, **Ronald Ozzy Lamola, (MP)**, Minister of Justice and Correctional Services assign the functions in terms of the Correctional Services Act, 1998 (Act 111 of 1998 as amended)

to

Nkosi S Phathekile Holomisa, (MP), Deputy Minister of Correctional Services;

to assist me in terms of section 93 of the Constitution of the Republic of South Africa, 1996 (Act no 108 of 1996.), which reads

"The President may appoint Deputy Ministers from among the members of the National Assembly to assist the members of Cabinet, and may dismiss them"

5. Oversee certain allocated Community Correction Programmes
6. Administration :
 - Public Service Act and Regulations, Public Finance Management Act and Treasury Regulations read with the, relevant sections in the Correctional Services Act 111 of 1998 as amended
 - Human Resources
 - GITO
 - Strategic Management

You will keep me informed about those matter of which I, in your opinion, need to take notice of and will consult me on policy matters and contentious issues.
