The Ministry for the Public Service and Administration does not have any public entities that report to it, but a set of departments and autonomous bodies that are within its portfolio.

PUBLIC SECTOR BODY		MANDATE
•	National School of Government	The current legislative mandate for the NSG is derived from section 4 of the Public Service Act, 1994. The Public Administration Management Act, 2014 also provides for the establishment of the National School of Government. Through the Department of Public Service and Administration (DPSA), a mechanism to align the NSG and the provisions of the Public Administration Management Act will be undertaken.
•	Centre for Public Sector Innovation (CPSI)	The Centre for Public Service Innovation (CPSI) is a Government Component established in terms of the Public Service Act, which reports to the Minister.
•	Department of Public Service and Administration	The DPSA is a national department that supports the Minister in exercising authority vested in the Minister through the Constitution of the Republic of South Africa, 1996 (the Constitution), the Public Service Act and the Public Administration Management Act.
•	Public Service Commission (PSC)	The PSC derives its mandate from sections 195 and 196 of the Constitution. The PSC is tasked and empowered to, amongst others, investigate, monitor, and evaluate the organisation and administration of the Public Service. The PSC is accountable to the National Assembly and must report annually to the Assembly. It must also report on its activities in each province to the Legislature of the province concerned. The Minister supports the PSC in tabling its legislation to Parliament when necessary.
•	Office of the Public Service Commissioner (OPSC)	This is a national department, headed by a Director-General, which supports the PSC.
