SOUTH AFRICAN CERTIFICATION COUNCIL

SOUTH AFRICAN CERTIFICATION COUNCIL ACT,
1986 (ACT NO. 85 OF 1986) AS AMENDED BY EDUCATION LAWS AMENDMENT ACT NO 48
OF 1999

CALL FOR COMMENTS ON THE AMENDMENTS TO PART 5 OF THE REGULATIONS OF THE SOUTH AFRICAN CERTIFICATION COUNCIL

1, Mokubung Nkomo, Chairperson of the South African Certification Council, after consultation with the members of the Council, hereby in terms of Section 18 of the *South African Certification Council Act, 1986*, relating to regulations on prescribed fees for the issue or endorsement of a certificate, request any person, society or organisation to submit to me, before Wednesday 10 January 2001 comments on the amendment to the existing regulations. This regulation was published in Government Gazette No. 13852 of 1992 under Regulation Notice R 862 of 1992.

The current regulations relating to the prescribed fees are as follows:

- [5. The moneys payable to the council in respect of the issuing of certificates are -
- (a) R7,00 in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass at a point of withdrawal;
 - (b) R2,00 per subject, with a maximum of R7,00 per candidate per examination occasion, in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass in a subject;
 - (c) R5,00 in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass at a point of withdrawal, where the certificate is issued to replace certificates of subjects passed, as well as an administration fee of R2,00 for each such certificate of subjects passed which cannot be handed in for cancellation;
 - (d) R5,00 in respect of the issuing of a duplicate of a certificate.]

The draft amended regulations are as follows:

5. The moneys payable to the council in respect of the issuing of certificates are -
- (a) R9,00 for 2001 and R12,00 for 2002 and thereon, in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass at a point of withdrawal;
 - (b) R3,00 for 2001 and R4,00 for 2002 and thereon, per subject with a maximum of R9,00 for 2001 and R12,00 for 2002 per candidate per examination occasion, in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass in a subject;
 - (c) R7,00 for 2001 and R9,00 for 2002 and thereon, in respect of the issuing of a certificate that a candidate has complied with the minimum requirements to pass at a point of withdrawal.

where the certificate is issued to replace certificates of subjects passed, as well as an administration fee of R3,00 for each such certificate of subjects passed which cannot be handed in for cancellation;

- (d) R7,00 for 2001 and R9,00 for 2002, and thereon, in respect of the issuing of a duplicate of a certificate.

Once all comments (received by 10 January 2001) have been considered, the draft regulations will be forwarded to the Minister of Education for his approval before it will be published in the Government Gazette as amendments to the Regulations R862 of 1992,
