MERCHANDISE MARKS ACT, 1941  
(ACT No. 17 OF 1941)

**PROHIBITION OF THE USE OF CERTAIN WORDS  
AND EMBLEMS**

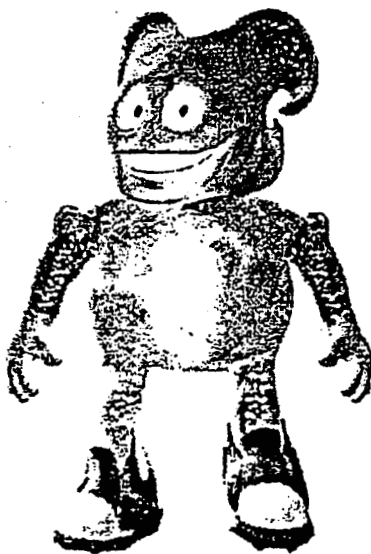
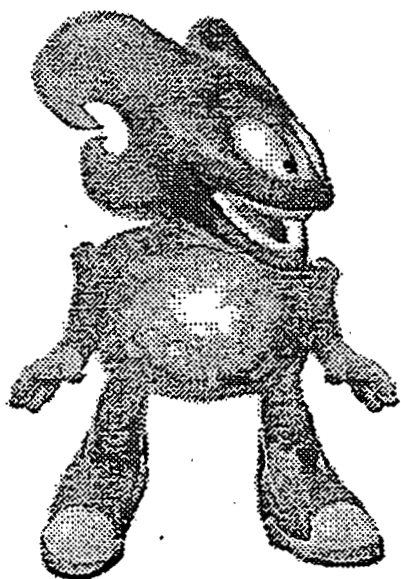
I, Alexander Erwin, Minister of Trade and Industry, hereby prohibit under section 15 (1) of the Merchandise Marks Act, 1941 (Act No. 17 of 1941), the use of the words "FIFA WORLD CUP KOREA JAPAN", "FIFA WORLD CUP", "2002 FIFA WORLD CUP", "FIFA", "WORLD CUP KOREA JAPAN 2002" and emblems, as depicted in the attachments, in connection with any trade, business, profession or occupation or in connection with a trade mark, mark or trade description applied to goods, other than the use thereof the above-mentioned body corporate or its mandatories. Proprietors of identical or similar marks already in use will not be affected by this prohibition.

Eienaars van identiese of soortgelyke merke wat reeds in gebruik is, sal nie deur hierdie verbod geraak word nie.
