SCHEDULE

Definitions

1. In these Rules, every word is given the same meaning as it is given by the Act and unless the context otherwise indicates:

"Construction Project Management" means the management of projects within the built environment from conception to completion, including the management of related professional services and the Construction Project Manager is the one point of responsibility in regard to the above;

"Construction Project Management" means the management of projects within the built environment from conception to completion, including the management of related professional services. And the Construction Project Manager is the one point of responsibility in regard to the above;

"the Act" means the Project And Construction Management Professions Act 48 of 2000; and "the CBE Act", means the Council For The Built Environment Act 43 of 2000.

Application for registration

- 2. (1) A person who wishes to register as a candidate or professional construction manager, or a candidate or professional construction project manager, must apply to the Registrar at Ground Floor, 9 Wellington Road, Parktown, Johannesburg 2001 or PO Box 2376, Houghton, 2041 on Form SACPCMP 1.
 - (2) The application must be accompanied by-
 - (a) the fee indicated in Schedule 1;
 - a certified copy of the identification document or passport of the applicant;
 - (c) certified copies of the educational qualification referred to in rule 3;
 - (d) a curriculum vitae of the applicant.

- (3) If the Registrar is satisfied that the applicant has submitted the required information and application fee, he or she must submit the application to the Council for consideration.
- (4) If the Council is satisfied that the applicant complies with the requirements in terms of these rules, the Council must issue to the applicant on payment of the registration and issuing fee, a registration certificate on the form indicated in Schedule 3.

Criteria for registration as candidate construction manager

- 3. (1) An applicant who wishes to register as a candidate construction project manager must possess an accredited four-year qualification in an accredited built environment field of study.
- (2) When registering an applicant in terms of this rule, the Council may consider the application of a person possessing a foreign educational qualification or a person with sufficient practical experience as contemplated in rule 4(2)(b)(i) and (ii).

Criteria for registration as professional construction manager

- 4. (1) An applicant who wishes to register as a Construction project manager shall:
 - (a) possess an accredited four year qualification in an accredited built environment field of study, and
 - (b) have a minimum of three years experience in a construction management environment or having been registered as a candidate construction manager, has worked under the guidance of a registered construction manager or a person eligible to be registered as such, and
 - (c) Prove such competencies by undergoing an examination or professional interview or both as set out by the councils registration committee.
 - (2) The Council may consider the following when registering an applicant:
 - (a) accredited educational qualifications may include foreign qualifications;
 - (b) practical experience in lieu of an approved educational qualification, provided that:
 - (i) the practical experience has been combined with courses of tertiary education and training applicable to the construction industry;
 - (ii) this alternative tertiary education and practical experience should have provided the applicant with equivalent technical knowledge to that which would have been obtained through an accredited educational qualification; and

 eight years of appropriate practical experience covering both professional and construction duties will be regarded as the minimum.

Criteria for registration as candidate construction project manager

- 5. (1) An applicant who wishes to register as a construction project manager shall possess an accredited four-year qualification in an accredited built environment field of study.
- (2) When registering an applicant in terms of this rule, the Council may consider the application of a person possessing a foreign educational qualification or a person with sufficient practical experience as contemplated in rule 4(2)(b)(i) and (ii).

Criteria for registration as a professional construction project manager

- 6. (1) An applicant who wishes o register as a construction project manager shall:
 - (a) possess an accredited four year qualification in an accredited built environment field of study, and
 - (b) have a minimum of three years experience in a project management environment or having been registered as a candidate construction project manager, has worked under the guidance of a registered construction project manager or a person eligible to be registered as such, and
 - (c) prove such competencies by undergoing an examination or professional interview or both as set out by the councils registration committee.
 - (2) The Council may consider the following when registering applicants:
 - (a) accredited educational qualifications may include foreign qualifications.
 - (b) practical experience in lieu of an approved Educational Qualification, provided that:
 - the practical experience has been combined with courses of tertiary education and training applicable to the construction industry;
 - (ii) this alternative tertiary education and practical experience should have provided the applicant with equivalent technical knowledge to that which would have been obtained through an accredited Educational Qualification; and
 - (iii) eight years of appropriate practical experience covering both professional and construction duties will be regarded as the minimum.

Title and abbreviation

- 7. (1) A person registered in terms of these rules as a candidate construction manager, may use the title "Candidate Construction Manager".
- (2) A Person registered as a professional construction manager, may use the title "Professional Construction Manager", abbreviated as "PrCM".
- (3) A person registered as a candidate construction project manager may use the title "Candidate Construction Project Manager".
- (4) A person registered as a professional construction project manager may use the title "Professional Construction Project Manager", abbreviated as "PrCPM".

Annual Fees

8. A person registered in terms of the Act is on the first day of January of every year, liable for the payment of the annual fee as indicated in Schedule 1.
