Amendment of Regulation 67.00.4 of Part 67 of the Regulations

2. Regulation 67.00.4 of the Regulations is herewith amended by the addition of the following sub-regulation after sub-regulation (3):

"(4) The application to be considered for the Designation as an Aviation Medical Examiner or Senior Medical Aviation Medical Examiner in terms of sub-regulation (1) shall be accompanied by-

- (a) information specified in Document SA-CATS-; and
- (b) by the appropriate fee as prescribed in Part 187."
