

BOARD NOTICE 21 OF 2003

This Board Notice is effective as from 1 April 2003

SCHEDULE

1. In This Schedule any expression or word bears the meaning assigned to it in the Natural Scientific Professions Act, 1993 (Act 106 Of 1993), and unless the context otherwise indicates –
 2. **"the Act"** means the Natural Scientific Professions Act, 1993 (Act 106 of 1993).
 3. **"the year"** means the period commencing on 1 April of any year and ending on 31 March of the next succeeding year.
 4. **"annual fee"** means the fee payable by the registered member –
 - (i) within 30 days from the date on which he/she is informed of his/her registration in terms of Section II of the Act and thereafter
 - (ii) annually on or before 30 April.
 5. **"registration fee"** means the fee payable when a person applied for registration in terms of Section II of the Act.
2. FEES
- (a) Registration fees:
 - (i) Professional Natural Scientist and Professional Natural Science Technologist: **R455,00 (VAT inclusive)**. Provided that a registration fee is payable for each category for which registration is requested and provided further that if an application for registration is not successful no fee shall be refunded to the applicant.
 - (ii) Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training: **R250.00 (VAT inclusive)**. Provided that a registration fee is payable for each category for which registration is requested and provided further that if an application for registration is not successful no fee shall be refunded to the applicant.
 - (iii) Upgrading of registration status: Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training: **R455.00 (VAT inclusive)**.
 - (iv) Reinstating after lapse of registration: Professional Natural Scientist/Professional Natural Science Technologist: **R455.00 (VAT inclusive)** and Professional Natural Scientist-in-training/Professional Natural Science Technologist-in-training: **R250.00 (VAT inclusive)**. Provided that a registration fee is payable for each category for which re-registration is requested.

(b) Annual fees:

- i) Professional Natural Scientist and Professional Natural Science Technologist: **R310.00 (VAT inclusive).**
- (ii) Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training: **R160.00 (VAT inclusive).**
Provided that if he/she has been registered as a Professional Natural Scientist-in-training or a Professional Natural Science Technologist-in-training for a period in excess of four years, the fee shall be **R310.00 (VAT inclusive).**
- (iii) Upgrading of registration status: Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training: **None.**
- (iv) Reinstating after lapse of registration: Professional Natural Scientist/ Professional Natural Science Technologist and Professional Natural Scientist-in-training/Professional Natural Science Technologist-in-training: **None.**
- (v) Pensioner: (all levels of registration): **R100.00 (VAT inclusive).**

(c) **No annual fees** will be payable in the **first** year of registration by:

- (i) Professional Natural Scientist and Professional Natural Science Technologist.
- (ii) Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training.
- (iii) Applicants upgrading their registration status from Professional Natural Scientist-in-training and Professional Natural Science Technologist-in-training.
- (iv) Applicants reinstating their registration (all levels of registration).
