PROCLAMATION

REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998 (ACT NO. 20 OF 1998): DETERMINATION OF SALARIES AND ALLOWANCES OF TRADITIONAL LEADERS, MEMBERS OF PROVINCIAL HOUSES OF TRADITIONAL LEADERS AND MEMBERS OF THE NATIONAL HOUSE OF TRADITIONAL LEADERS FOR THE 2001/2002 AND 2002/2003 FINANCIAL YEARS

Under section 5(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998), I hereby –

- (a) (i) after consultation with the Premiers concerned;
 - (ii) after taking into consideration the matters listed in paragraphs (a) to (h) of section 5 (1) of that Act; and
 - (iii) for the 2001/2002 financial year and the 2002/2003 financial year as indicated in the Schedule;
- (b) determine that
 - traditional leaders shall be entitled to the salaries as set out in the Schedule;
 - (ii) members of the National House of Traditional Leaders shall, in addition to their salaries as traditional leaders, be entitled to an allowance in respect of actual meetings of the National House of Traditional Leaders, or a committee thereof, and seminars, workshops and conferences attended on behalf of the National House of Traditional Leaders as set out in the Schedule; and

(iii) members of a provincial House of Traditional Leaders shall, in addition to their salaries as traditional leaders, be entitled to an allowance in respect of actual meetings of the provincial House of Traditional Leaders concerned, or a committee thereof, and seminars, workshops and conferences attended on behalf of the provincial House of Traditional Leaders concerned, as set out in the Schedule.

Definitions
