DRAFT SECOND-HAND GOODS BILL: DRAFT SECOND-HAND GOODS REGULATIONS

REGULATIONS

1. Definition

In these Regulations any word or expression to which a meaning has been assigned in the Act shall bear that meaning and, unless the context otherwise indicates -

"the Act" means the Second-Hand Goods Act. 200x (Act No. xx of 200x).

2. Form of application

An application for a certificate, as contemplated in subsection (1) of section *four* of the Act, shall in all cases be substantially in the form prescribed in Schedule A and completed in indelible black ink and submitted by hand to the client service centre at the police station in the area where the applicant intends to have or has his or her place of business.

3. Application to be made before 1 November

An application for a certificate, shall be made on or before 1 November of the year in which the certificate to be renewed, expires.

4. Information and documents to accompany application

The application shall be accompanied by such information and documentation as may be required in terms of Schedule A.

5. Acknowledgement of receipt

An acknowledgement of receipt shall be handed to the applicant if the application is complete and accompanied by the relevant documentation.

6. Certificate

The certificate issued to the applicant shall substantially be in the form prescribed in Schedule B and must be displayed in a manner visible to the public. In the case of a pawnbroker, the certificate issued in terms of the Act shall be displayed next to the certificate issued by the MFRC.

Permanent change of address or circumstances

- Where a permanent change occurs in the ordinary place of recidence or business of the holder of a certificate, such holder of a certificate shall submit to the Station Commissioner of the police station in the area where he or she has his or her business, the notification of change of address on the applicable portion prescribed in Schedule A.
- Where a permanent change occurs in the information which the holder of a certificate submitted in respect of the application for the issuing of that certificate, such holder of a certificate shall submit to the officer in charge of the policing precinct in which he or she has his or her business the notification of change of circumstances on the applicable portion prescribed in Schedule A.

8. Registers to be kept by dealers and pawnbrokers

(1) The register of aquisition to be kept by dealers in terms of section seven of the Act. shall

substantially be in the form prescribed in Schedule C.

- (2) The register of disposal to be kept by dealers in terms of section *seven* of the Act. shall substantially be in the form prescribed in Schedule D.
- (3) The register of goods taken in pawn to be kept by pawnbrokers in terms of section *eight* of the Act. shall substantially be in the form prescribed in Schedule E.

9. Notice of appeal

Notice of an appeal, as contemplated in subsection (1) of section six of the Act, must be lodged at the police station where the application was refused

10. Commencement

These regulations shall come into operation with immediate effect.
