MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT No. 47 OF 1996), AS AMENDED

AMENDMENTS OF STATUTORY MEASURES FOR MAIZE, OILSEEDS, SORGHUM AND WINTER CEREAL

I, Angela Thokozile Didiza, Minister of Agriculture, acting in terms of sections 13, 18 and19 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996) as amended, hereby -

- (a) publish the amendments as set out in the Schedule hereunder of the Statutory Measures as were respectively published by Government Notices Nos.:
 - (i) R.1044 and R.1047 of 27 October 2000 Statutory Measures for Maize;
 - R.1045 and R.1049 of 27 October 2000, as amended by Government Notice R.522 of 15 June 2001 – Statutory Measures for Oilseeds;
 - (iii) R.1042 and R.1046 of 27 October 2000 Statutory Measures for Sorghum;
 - (iv) R.1048 and R.1043 of 27 October 2000, as amended by Government Gazette Notice R.523 of 15 June 2001 – Statutory Measures for Winter Cereal; and
- (b) declare that the said amendments will commence on the date of publication hereof.

SCHEDULE

Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the respective Statutory Measures, as were published by the Government Notices as set out in paragraph (a) above, will have that meaning.

Amendment of the Definitions in clause 1 of the Statutory Measures for Maize

- The Statutory Measures for Maize as published by Government Notices Nos.
 R.1044 and R.1047 of 27 October 2000 are amended as follows:
- 2.1 The definition of "storer" is replaced by the following definition:

"storer" – means a person with storage facilities of 500 tons or more, where maize is handled for commercial purposes.

2.2 The following definition is inserted before the definition of "end-consumer":

"commercial purposes" – means where an income, remuneration or benefit is obtained.

Amendment of the Statutory Measures for Oilseeds

3. The definitions in clause 1 of the Statutory Measures for Oilseeds as published by Government Notices Nos. R.1045 and R.1049 of 27 October 2000 are amended as follows:

3.1 The definition of "storer" is replaced by the following definition:

"storer" – means a person with storage facilities of 500 tons or more, where oilseeds are handled for commercial purposes.

3.2 The following definition is inserted after the definition of "canola":

"commercial purposes" – means where an income, remuneration or benefit is obtained.

- The Statutory Measures for Oilseeds as published by Government Notice No. R.1049 of 27 October 2000 are amended as follows:
- 4.1 Section 5(2)(e)(i) is amended by inserting the following paragraph after section 5(2)(e)(i)(ff):

"(gg) groundnut pods"

4.2 Section 5(3)(a) is amended by replacing the words "edible market and crush grade groundnuts" by the words "choice, sundries and crushing groundnuts".

Amendment of the Definitions in clause 1 of the Statutory Measures for Sorghum

- 5. The Statutory Measures for Sorghum as published by Government Notices Nos. R.1042 and R.1046 of 27 October 2000 are amended as follows:
- 5.1 The definition of "storer" is replaced by the following definition:

"storer" – means a person with storage facilities of 500 tons or more, where sorghum is handled for commercial purposes.

5.2 The following definition is inserted before the definition of "end-consumer":

"commercial purposes" - means where an income, remuneration or benefit is obtained.

Amendment of the Definitions in clause 1 of the Statutory Measures for Winter Cereal

- The Statutory Measures for Winter Cereal as published by Government Notices Nos. R.1043 and R.1048 of 27 October 2000 are amended as follows:
- 6.1 The definition of "storer" is replaced by the following definition:

"storer" – means a person with storage facilities of 500 tons or more, where winter cereal is handled for commercial purposes.

6.2 The following definition is inserted before the definition of "end-consumer":

"commercial purposes" – means where an income, remuneration or benefit is obtained.

- 6.3 The definition of "verwerker" of the Statutory Measures for Winter Cereal as published by Government Notice No. R.1043 of 27 October 2000 is amended by replacing the word "mielieprodukte" with the word "wintergraanprodukte".
- 6.4 The definition of "hanteer" of the Statutory Measures for Winter Cereal as published by Government Notice No. R.1048 of 27 October 2000 is replaced by the following definition:

"hanteer" ook ontvang, opberg, versend of verwerk.
