- 1.2 Norcros SA (Pty) Ltd is an expansion project manufacturing ceramic floor tiles, with a total investment of R102 332 000,00 and qualifying assets of R102 332 000,00. The project is classifiable under SIC code 34230 and HSC 284410.

2. SUMMARY OF EVALUATION PROCESS

On 26 August 2003, I as the Minister of Trade and Industry endorsed the recommendation of the Strategic Industrial Projects Adjudication Committee meeting of 14 August 2003 not to approve the application of Norcros SA (Pty) Ltd as a Strategic Industrial Project (SIP) in terms of Section 12G of the Income Tax Act (Act No. 58 of 1962), as amended and the relevant Regulations. The project failed to comply with the mandatory requirement on industrial assets as contemplated in the Act and Regulation. Norcros is a turnkey project and has contracted for assets prior to the SIP approval. The industrial assets were also on site and in the republic prior to the SIP approval.
