## NOTICE OF APPLICATION FOR AMENDMENT OF THE DEFINITION OF PRODUCTION AREA: WALKER BAY

(In terms of Section 6 of the Wine of Origin Scheme established under section 14 of the Liquor Products Act, 1989 (Act No. 60 of 1989), and published by Government Notice No. R.1434 of 29 June 1990)

Notice is hereby given that E P Theron has applied to the Wine and Spirit Board to amend the definition of the area known as Walker Bay (ward) as set out in Government Notice R2164 of 16 October 1981 and by the substitution herefor of the definition in the Schedule hereto.

Anyone having any objection against this application is hereby notified to lodge their objections, with motivations, in writing with the Secretary, Wine and Spirit Board, P O Box 2176, Dennesig, Stellenbosch, 7599 within 30 (thirty) days of publication of this notice.

## **SCHEDULE**

## **DEFINING OF PRODUCTION AREA WALKER BAY**

That portion of the former Divisional Council Area of Caledon situate within the following boundaries:

Beginning at the point where the western boundary of the land known as The Draay, just east of the township area of Kleinmond, meets the Atlantic Ocean; thence first northwards and then eastwards along the western and northern boundaries of said The Draay; thence further in a north-easterly direction along the north-western boundary of the land known as Hermanus River to the most northern point of said Hermanus River; thence in a general northeasterly direction along the western boundary of the land known as Vredendal, Bot River Outspan and Compagnies Drift to the most northern point of said Annex Compagnies Drift No 2; thence generally south-eastwards with the north-eastern boundary of said Compagnies Drift No 2 and further with the north-eastern boundary of the land known as Roode Heuvel to the most eastern point of said Roode Heuvel; thence generally southwards with the eastern boundary of said Roode Heuvel, the land known as Bot River and Josephs Kraal to the most eastern point of said Josephs Kraal; thence generally eastwards with the southern boundary of the land known as Berg Randt to the most eastern point of said Berg Randt; thence north-eastwards, then south-eastwards and eventually generally southwards with respectively the north-western, north-eastern and eastern boundary of the land known as Lot D SWF 746 and finally generally westwards with the southern boundary of said Lot D SWF 746 to the most western point thereof; thence first southeastwards and then south-westwards with the south-eastern boundary of the land known as Attaquas Kloof and the north-western boundary of the land known as Glen Varloch to the most western point of said Glen Varloch; thence eastwards with the general southern boundary of the land known as Glen Varloch, Vogel Gat, Belle Vue, Morning Star, Uitzight, Klippies Berg 628, Farms 627, 626 and 625 to the south-eastern beacon of last-mentioned farm; thence south with the eastern boundaries of Klein Rivier Kloof 660 and Farm

662 to where it joins the north-western beacon of Paardenbergs Rivier 663; thence south-east with an imaginary straight line to the south-western beacon of Farm 731; thence further south-east with the south-western boundary of said Farm 731 to the southern beacon thereof; thence north-east with an imaginary straight line to trigonometric beacon 152, Tafelberg; thence southeast with the eastern boundary of farm 667 to the south-eastern beacon thereof; thence further south-east with an imaginary straight line, which is an extension of the south-eastern boundary of said farm 667, to where it joins the southern boundary of farm 668; thence south-west with the southern boundary of said farm 668 to where it joins the north-eastern beacon of Sondags Kloof 672; thence generally south-west with the general eastern boundary of said Sondags Kloof 672 to where it joins the eastern beacon of Paapjes Valley 679; thence south with the eastern boundary of said Paapjes Valley 679 to where it joins the general northern boundary of Landmeters Kop 681; thence south-west with an imaginary straight line to where it joins the north-eastern beacon of Farm 682; thence generally south-west and then west with the general southern boundaries of Farms 682 and 683, Goed Vertrouw 684, Farm 685 and Helderfontein 688 to the south-western beacon thereof; thence generally south-westwards with the south-eastern boundary of the land known as Baviaans Uitzicht, Baviaans Fonteyn, Bosch Bok Randt, Bergyliet and Strandfonteyn to the most south-western point of said Strandfonteyn; thence westwards with the southern boundary of said Strandfonteyn to where said boundary meets the Atlantic Ocean; thence generally northwards and north-westwards with the coastline of the bay known as Walker Bay to the point where the western boundary of the land known as The Draay meets the Atlantic Ocean, the point of beginning mentioned above.
