MAGISTRATES ACT, 1993 REGULATIONS FOR JUDICIAL OFFICERS IN THE LOWER COURTS, 1994: **AMENDMENT**

The Minister for Justice and Constitutional Development has under section 16 of the Magistrates Act, 1993 (Act No. 90 of 1993), on the recommendation of the Magistrates Commission, made the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 361 of 11 March 1994, as amended by Government Notices Nos. R. 644 of 1 April 1994, R. 1407 of 11 August 1994, R. 1808 of 17 October 1994, R. 1707 of 27 October 1994, R. 1791 of 17 November 1995, R. 72 of 26 January 1996, R. 331 of 1 March 1996, R. 957 of 7 June 1996, R. 1178 of 19 July 1996, R. 1242 of 2 August 1996, R. 1340 of 12 August 1996, R. 1567 of 27 September 1996, R. 1627 of 1 October 1996, R. 178 of 7 February 1997, R. 421 of 20 March 1997, R. 1081 of 8 August 1997, R. 274 of 20 February 1998, R. 997 of 7 August 1998, R. 56 of 15 January 1999, R. 1498 of 17 December 1999 and R. 1339 of 26 September 2003.

Amendment of Classification of Regulations

Amendment of regulation 1 of the Regulations

- 3. Regulation 1 of the Regulations is hereby amended by -
 - (a) the insertion of the following definition after the definition of "candidate":"court manager' the court manager at the court where a magistrate is performing his or her duties;"; and
 - (b) the insertion of the expression "or partner" after the expression "spouse" wherever it appears in the regulations.

insertion of regulations 54B and 54C in the Regulations

4. The following regulations are hereby inserted after regulation 54A of the Regulations:

"PART XXII: PARTNER

Registration of partner

- A magistrate who wishes to register a person as his or her partner 54B.(1) must complete Form 1 of Schedule F.
- (2) A completed Form 1 of Schedule F must
 - be accompanied by -(a)
 - (i) certified copies of the identity documents of the magistrate and the person to be registered as partner; and
 - an affidavit by a person confirming the existence of a (ii) relationship between the magistrate and the person to be registered as partner; and
 - (b) together with the documents contemplated in paragraph (a) be submitted in duplicate to the court manager.
- (3)The court manager must
 - on receipt of the documents contemplated in subregulation (2) affix (a) the official stamp of the Department with the date of receipt on all pages of both copies of Form 1 of Schedule F and the attachments thereto:
 - (b) return one copy of Form 1 of Schedule F and the attachments thereto to the magistrate; and
 - enter the following in a register kept for this purpose: (c)
 - the date of receipt of Form 1 of Schedule F; (i)
 - (ii) the particulars of the magistrate and the person to be registered as partner; and
 - forthwith forward the retained copy of Form 1 of Schedule F and the (d) attachments thereto to the Director-General.

Deregistration of partner

- 54C.(1) A magistrate who wishes to deregister a person who was registered as his or her partner in terms of regulation 54B(1) must complete Form 2 of Schedule F.
- (2) A completed Form 2 of Schedule F must be submitted in triplicate to the court manager.
- (3) The court manager must -
 - (a) on receipt of the documents contemplated in subregulation (2) affix the official stamp of the Department with the date of receipt on all pages of all the copies of Form 2 of Schedule F;
 - (b) return two copies of Form 2 of Schedule F to the magistrate;
 - (c) enter the following in a register kept for this purpose:
 - (i) the date of receipt of Form 2 of Schedule F;
 - (ii) the particulars of the magistrate and the person to be deregistered as partner; and
 - (d) forthwith forward the retained copy of Form 2 of Schedule F to the Director-General.
- (4) The magistrate contemplated in subregulation (1) must -
 - (a) by registered post send one of the copies of Form 2 of Schedule F contemplated in subregulation (3)(b) to the last known address of the person who is to be deregistered as his or her partner; and
 - (b) keep proof of having posted the copy to the relevant person.".
