### INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

NOTICE REGARDING WRITTEN SUBMISSIONS RECEIVED BY THE AUTHORITY FOR THE UNDER SERVICED AREA LICENCES IN TERMS OF SECTION 34(3)(a) OF THE TELECOMMUNICATIONS ACT NO.103 OF 1996, AS AMENDED ("THE ACT")

The Independent Communications Authority of South Africa ("the Authority") hereby gives notice:

- 1. that pursuant to Government Gazette No.25591 of 14 October 2003, which invited written submissions from interested parties regarding applications received for under-serviced area licences ("USAL");
- 2. that the Authority received representations from the following entities:
