

BOARD NOTICE 16 OF 2004**NOTICE OF APPLICATION FOR DEFINING OF PRODUCTION AREA
OUTENIQUA**

(In terms of Section 6 of the Wine of Origin Scheme established under section 14 of the Liquor Products Act, 1989 (Act No. 60 of 1989), and published by Government Notice No. R.1434 of 29 June 1990)

Notice is hereby given that Langkloof Vineyards CC has applied to the Wine and Spirit Board for the defining of the area known as Outeniqua (ward) as an area for the production of Wine of Origin as described in the Schedule hereto.

Anyone having any objection against this application is hereby notified to lodge their objections, with motivations, in writing with the Secretary, Wine and Spirit Board, P O Box 2176, Dennesig, Stellenbosch, 7599 within 30 (thirty) days of publication of this notice.

SCHEDULE**DEFINING OF PRODUCTION AREA OUTENIQUA**

That portion of land situate within two separate mountain enclaves within the following boundaries:

1. The western portion

Start at the point where the northern boundary of Waboomskraal Noord 87 intersects the Waboomskraal River; thence south with said river to a point where the north-eastern boundary of Croxden 90 intersects said river; thence south-east with the general eastern boundaries of said Croxden 90, Smuts Kloof 94 and farm 308 to the south-eastern beacon thereof; thence west with the southern boundaries of said farm 308, Hollekloof 91, Kouwdouw 88, farm 315 and Kouwdouw 88 to the south-western beacon thereof; thence north-east with the eastern boundary of said Kouwdouw 88 to the south-eastern beacon of Waboomskraal Noord 87; thence first south-west and then north-east with the southern, general north-western and northern boundaries of said Waboomskraal Noord 87 to a point where last-mentioned boundary intersects the Waboomskraal River; the point of beginning mentioned above.

2. The eastern portion

Start at the point where the railway line from Oudtshoorn to George intersects and imaginary straight line, drawn from the south-western beacon of Doorn Rivier 98 eastward to the northern beacon of Afgunst 99; thence east with said imaginary straight line to said eastern beacon of Afgunst 99; thence first south, then south-west and then generally north-west with the general northern boundaries of the Witfontein Nature Reserve to the south-western beacon of said Doorn Rivier 98; thence east with an imaginary straight line, drawn from the south-western beacon of Doorn Rivier 98 to the northern beacon of Afgunst 99, to the point where the railway line from Oudtshoorn to George intersects said imaginary straight line, the point of beginning mentioned above.
