Notice is hereby given that Langkloof Vineyards CC has applied to the Wine and Spirit Board for the defining of the area known as Upper Langkloof (ward) as an area for the production of Wine of Origin as described in the Schedule hereto.

## SCHEDULE

## DEFINING OF PRODUCTION AREA UPPER LANGKLOOF

That portion of land situate within the following boundaries:

Start at the point where the N12 road from Oudtshoorn to George intersects the north-western boundary of Palmiet Drift 80; thence north-east with said boundary to a point where an imaginary straight line, drawn from trigonometric beacon 33 to the north-western beacon of Soldaats Kraal 97, intersects said boundary; thence south-east with said imaginary straight line to said northwestern beacon of Soldaats Kraal 97; thence generally east with the general northern boundaries of said Soldaats Kraal 97, Doorn Rivier 98, Grootfontein 102, Grootfontein 314, Ezeljagt C 313, Lower Schooneberg 108, Schooneberg 109, Sheep Walk 66, Ganze Kraal 63, Doornkloof 62, Eenzaamheid 60, Groot Fontein 57 and Dieppe Rivier 56 to the north-eastern beacon thereof; thence south with the eastern boundaries of said Dieppe Rivier 56 and Klein Lang Kloof 116 to the south-eastern beacon thereof; thence generally west with the general southern boundaries of said Klein Lang Kloof 116, Eenzaamheid 60, Doornkloof 62, Ganze Kraal 63, Sheep Walk 66, Schooneberg 109, Lower Schooneberg 108, Ezeljagt B 312, Ezeljagt A 311 and Annex Groot Fontein 101 to the north-western beacon thereof; thence west with an imaginary straight line to the south-eastern beacon of Soldaats Kraal 97; thence further west with the general southern boundaries of said Soldaats Kraal 97 and Palmiet Drift 80 to the westernmost beacon thereof; thence north-east with the north-western boundary of said Palmiet Drift 80 to a point where the N12 road from Oudtshoorn to George intersects said boundary, the point of beginning mentioned above.
