Representations in accordance with section 16(3) of Act No. 60 of 1993 and regulation

25 (1) of the International Air Services Regulations, 1994, against or in favour of an application, should the Chairman of the Council at Private Bag X 193, Pretoria, 0001 within 28 days of the publication hereof. It must be stated whether the party or parties making such representation is/are prepared to be present or represented at the possible hearing of the application.

The Council will cause notice of the time, date and place of the proceedings to be given in writing to the applicant and all parties who had made representation as aforesaid and who desire to be present or represented at the hearing.
