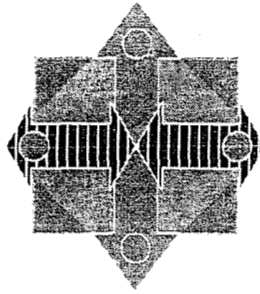

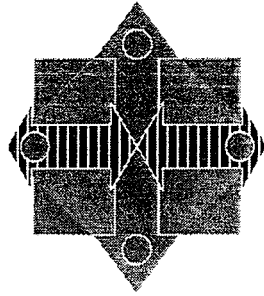
**REQUEST FOR THE INTRODUCTION OF STATUTORY MEASURES IN
THE SOUTH AFRICAN WOOL INDUSTRY (STATUTORY MEASURES
FOR REGISTRATION AND RECORDS & RETURNS) IN TERMS OF THE
MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996**

The Minister for Agriculture and Land Affairs received a request from Cape Wools SA for the introduction of statutory measures (statutory registration and records & returns) on wool. The proposed statutory measures are applicable to brokers, traders, processors, importers and exporters of wool.

As the statutory measures requested by Cape Wools SA (executive arm of the Wool Industry Forum of South Africa), are consistent with the objectives of the Marketing of Agricultural products Act, 1996, the Minister has requested the National Agricultural Marketing Council to investigate the possible implementation of the relevant statutory measure and to report back to her within 60 days.

Explanatory notes regarding the proposed introduction of statutory measures are available at the officers of the Council. The relevant explanatory notes will also be published in the *Government Gazette* of 21 May 2004.

Directly affected groups in the wool industry are kindly requested to submit any comments or objections regarding the proposed statutory measures to the National Agricultural Marketing Council in writing before or 4 June 2004, to enable the Council to formalize its recommendation to the Minister in this regard.
