NOTICE OF APPLICATION FOR DEFINING OF PRODUCTION AREA KLEIN RIVER

(In terms of Section 6 of the Wine of Origin Scheme established under section 14 of the Liquor Products Act, 1989 (Act No. 60 of 1989), and published by Government Notice No. R.1434 of 29 June 1990)

Notice is hereby given that P G V Dreyer has applied to the Wine and Spirit Board for the defining of the area known as Klein River (ward) as an area for the production of Wine of Origin as described in the Schedule hereto.

Anyone having any objection against this application is hereby notified to lodge their objections, with motivations, in writing with the Secretary, Wine and Spirit Board, P O Box 2176, Dennesig, Stellenbosch, 7599 within 30 (thirty) days of publication of this notice.

SCHEDULE

That portion of land situate within the following boundaries:

Start at the point where the Caledon/Napier Road intersects the eastern boundary of Hansjes River 616; thence first south and then south-west with the eastern and southern boundaries of said Hansies River 616 to where it joins the south-eastern beacon of farm 617; thence south-west with the northeastern boundary of farm 322 tot where it joins the north-eastern boundary of farm 333; thence first south-east and then south-west with the north-eastern and south-eastern boundaries of said farm 333 to where it joins the southeastern beacon of farm 322; thence generally west with the southern boundary of said farm 322 tot where it joins the eastern boundary of farm 668; thence first south-west then north-west and again south-west with the southeastern and general southern boundaries of said farm 668 to a point where an imaginary straight line, which is an extension of the south-eastern boundary of farm 667, intersects the said southern boundary; thence north with said imaginary straight line and the south-eastern boundary of said farm 667 to trigonometric beacon 152, Tafelberg; thence south-west with an imaginary straight line to where it joins the southern beacon of farm 731; thence northwest with the southern boundary of said farm 731 to the south-western beacon thereof; thence further north-west with an imaginary straight line to the south-western beacon of farm 620; thence north with the western boundaries of said farm 620 and Hagedisberg Outspan 661 to where it joins the southeastern beacon of farm 625; thence generally west with the general southern boundaries of said farm 625, farms 626, 627 and Klippies Berg 628 to the south-western beacon of last-mentioned farm; thence generally north with the western boundaries of said Klippies Berg 628 and farms 606, Hartebeeste River 607 and farm 221 tot where the Hartebees River intersects the western boundary of said farm 221; thence up stream with said river to where it intersects the south-western boundary of Dunghye Park 528; thence southeast with the south-western boundary of said Dunghye Park 528 to where it joins the north-western beacon of Solitaire 727; thence generally east with the general northern boundaries of said Solitaire 727, Hartebeeste River 607,

Kleyn Wolve Gat 608 and Bosch River 609 to the north-eastern beacon of last-mentioned farm; thence east with an imaginary straight line, which is an extension of the northern boundary of Bosch River 609, to a point where it intersects the Caledon/Napier Road; thence south-east with said Caledon/Napier Road to a point where it intersects the eastern boundary of Hansjes River 616, the point of beginning mentioned above.
