NOTICE THAT INTERCONNECTION AND FACILITIES GIUDILINES WILL BE AMENDED

Pursuant to the Telecommunications Amendment Act No 2 of 2004 ("Act 2 of 2004"), the Authority intends to amend the interconnection and facilities guidelines and the supplements thereto to bring them in line with Act 2 of 2004. Sections 3A and 5A of Act 2 of 2004 make provision for the purposes of guidelines prescribed in terms of section 43 (3) and 44 (5) an operator licensed in terms of section 32B, 32C,36,37,38,39 and 40A have powers and shall perform the duties of a Public Operator.
