#### **NOTICE OF HEARINGS FOR THE SOUTH AFRICAN BROADCASTING CORPORATION'S (SABC) AMENDMENT APPLICATION IN TERMS OF SECTION 22 OF THE BROADCASTING ACT.**

1. The Independent Communications Authority of South Africa (ICASA) hereby gives notice in accordance with the provisions of section 42 (2) of the Independent Broadcasting Authority Act No. 153 of 1993 as amended, that hearings will be conducted in respect of the SABC's amendment application in terms of section 22 of the broadcasting Act, Act 4 of 1999. According to the applicant, the proposed amendment will result in the licences reflecting the re-organisation of the SABC's services into a Public Service Division and a Commercial Service Division and its related obligations in terms of the Broadcasting Act and the Independent Broadcasting Authority Act.
2. The Gauteng hearings will take place at the ICASA offices, Block C presentation room, Pinmill Farm, 164 Katherine Street, Sandton. The venues for the hearings in the Limpopo Province and the Western Cape will be posted on the ICASA website at [www.icasa.org.za](http://www.icasa.org.za).
