DECLARATION OF EXISTING PROVINCIAL ROADS — (I) PROVINCIAL ROAD P43 SECTION 1, (II) PROVINCIAL ROAD P43 SECTION 2, AND (III) PROVINCIAL DISTRICT ROAD No. 9 AS NATIONAL ROAD R81 — DISTRICTS OF POLOKWANE (PIETERSBURG), THABAMOOPO, LETABA 1, BOLOBEDU AND GIYANI.

By virtue of section 40(1)(a) of The South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) the Section of Provincial Road P43 Section 1, also known as R81, commencing from the intersection with National Road N1 Section 27, up to Munnik Township where it joins Provincial Road P43 Section 2, (II) the Section of Provincial Road P43 Section 2, also known as R81, continuing from Sekgopo (Munnik) Township where it joins Provincial Road P43 Section 1 up to the junction with Provincial District Road No. 9: and; (III) the Section of Provincial District Road No. 9, also known as R81, continuing from the junction with Provincial Road R36 at Mooketsi Township up to Giyani Township, as described in the Annexure hereto, to be a National Road.

(I) Description of existing proclaimed Provincial Road P43-1 between Polokwane and Sekgopo (Munnik)

The Section of Route R81, also known as Provincial Road P43-1, as previously declared by Administrative Notices as Provincial Road, commencing from the intersection with the National Road N1 Section 27 on the farm Tweefontein 915 – LS, as declared by Declaration No. 1392 of 1982, there from on proceeding in a general North-Easterly direction on existing Provincial Road P43-1 up to the junction with Provincial Road P43-2 on the farm Bloomfield 829 – LS at Sekgopo (Munnik) Township.

(II) Description of existing proclaimed Provincial Road P43 -2 between Sekgopo (Munnik) and the junction with Provincial District Road no. 9

The Section of Route R81, also known as Provincial Road P43-2, as previously declared by Administrative Notices as Provincial Road, continuing from the junction with Provincial Road P43-1 on the farm Bloomfield 829 – LS at Sekgopo (Munnik) Township there from on proceeding in a general North-Easterly direction on existing Provincial Road P43-2, up to the junction with Provincial District Road No. 9, on the farm Billesdon 374 - LT.

[Sekgopo (Munnik) - Mooketsi]

(III) Description of existing proclaimed Provincial District Road 9 between the junction with Provincial Road R36 and Giyani.

The Section of Route R81, also known as Provincial District Road 9, as previously declared by Administrative Notices as Provincial District Road, continuing from the junction with Provincial Road R36, also known as Provincial Road P43-2, on the Farm Billesdon 374 – LT, there from on proceeding in a general North-Easterly direction on existing Provincial District Road No. 9 through Mooketsi Township up to the Northern abutment of the Klein Letaba River bridge at Giyani, where it terminates.
