



DECLARATION OF EXISTING PROVINCIAL ROADS – (I) PROVINCIAL ROAD P51 SECTION 1, AND (II) PROVINCIAL ROAD P83 SECTION 1 AS NATIONAL ROAD N11 – DISTRICTS OF MOKOPANE (POTGIETERSRUS) AND MOKERONG 2.

By virtue of section 40(1)(a) of The South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) the Section of Provincial Road P51 Section 1, also known as N11, commencing from the Limpopo / Mpumalanga Provincial Border up to the junction South of Mokopane Township with National Road N1 Section 25X and; (II) the Section of Provincial Road P83 Section 1, also known as N11, continuing from the junction with Ficus street in Mokopane Township up to Groblersbrug Border Post, as described in the Annexure hereto, to be a National Road.

ANNEXURE**(I) Description of existing proclaimed Provincial Road P51-1 between Limpopo/Mpumalanga Provincial Border and the junction with National Road N1 Section 25X.**

The Section of Route N11, also known as Provincial Road P51 Section 1, as previously declared by Administrative Notices as Provincial Road, commencing from its intersection with the Limpopo/Mpumalanga Provincial Border on the farm Boschhoek 703 – KS, there from on proceeding in a general North-Westerly direction on existing Provincial Road P51-1 up to a point South of Roedtan Township at the junction with Bosman Street, where it terminates.

Again commencing from a point North of Roedtan Township at the junction with Provincial Road R519, also known as Provincial Road P134-2, there from on proceeding in a general North-Westerly direction on existing Provincial Road P51-1 up to the junction with National Road N1-25X on the farm Moorddrift 289 – KR, South of Mokopane Township as declared by Declaration No. 2446 of 1992, where it terminates.

(Limpopo/Mpumalanga Provincial Border – Mokopane)

(II) Description of existing proclaimed Provincial Road P83-1 between Mokopane and Groblersbrug Border Post.

The Section of Route N11, also known as Provincial Road P83-1, as previously declared by Administrative Notices as Provincial Road, again commencing from a point North-West of Mokopane Township at the junction with Ficus street, there from on proceeding in a general North-Westerly direction on existing Provincial Road P83-1 through Mahawelereng Township up to a point where it joins the Groblersbrug Border Post National Road Declaration as depicted on Declaration Plan No. P505/2002 on the farm Klippan 25 – LQ, where it terminates.
