DECLARATION OF EXISTING PROVINCIAL ROADS – (I) PROVINCIAL ROAD P54 SECTION 1, (II) PROVINCIAL DISTRICT ROAD 1308, (III) PROVINCIAL ROAD P43 SECTION 2, (IV) PROVINCIAL ROAD P17 SECTION 2, (V) PROVINCIAL ROAD P43 SECTION 3 (VI) PROVINCIAL ROAD P112 SECTION 2, (VII) PROVINCIAL ROAD P17 SECTION 3, (VIII) PROVINCIAL ROAD P17 SECTION 4: AND; (IX) PROVINCIAL ROAD P17 SECTION 5 AS NATIONAL ROADS R36, R71, R526 AND R40 – DISTRICTS OF SOUTPANSBERG, SEKGOSESE 2, LETABA 1, PHALABORWA AND MAPULANENG.

By virtue of section 40(1)(a) of The South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) the Section of Provincial Road P54 Section 1, also known as R36, from the National Road N1 Section 28 South of Makhado Township up to the junction with Provincial District Road 1308, (II) the Section of Provincial District Road 1308, also known as R36, continuing from the junction with Provincial Road P54 Section 1 up to the junction with Provincial Road P43 Section 2, (III) the Section of Provincial Road P43 Section 2, also known as R36, continuing from the junction with Provincial District Road 1308 up to the junction with Provincial Road P17 Section 2. (IV) the Section of Provincial Road P17 Section 3, also known as R36, continuing from the junction with Provincial Road P43 Section 2 up to the junction with Provincial Road P43 Section 3. (V) the Section of Provincial Road P43 Section 3, also known as R71, continuing from the junction with Provincial Road P17 Section 3, up to the junction with Provincial Road P112 Section 2, (VI) the Section of Provincial Road P112 Section 2, also known as R71, continuing from the junction with Provincial Road P43 Section 3 up to the junction with Provincial Road P17 Section 3, (VII) the Section of Provincial Road P17 Section 3, also known as R526, continuing from the junction with Provincial Road P112 Section 2 up to the junction with Provincial Road P17 Section 4, (VIII) the Section of Provincial Road P17 Section 4, also known as R40, continuing from the junction with Provincial Road P17 Section 3 up to the junction with Provincial Road P17 Section 5: and; (IX) the Section of Provincial Road P17 Section 5, also known as R40, continuing from the junction with Provincial Road P17 Section 4 up to the intersection with the Limpopo/Mpumalanga Provincial Border, as described in the Annexure hereto, to be a National Road.

ANNEXURE

I) Description of existing proclaimed Provincial Road P54 -1 between the N1 and the junction with Provincial District Road No. 1308

The Section of Route R36, also known as Provincial Road P54-1, as previously declared by Administrative Notices as Provincial Road, commencing from its junction with the National Road N1-28 on the farm Joppa 473 - LS as declared by Declaration No.1322 of 1989, there from on proceeding in a general South-Easterly direction on existing Provincial Road P54-1 up to the junction with Provincial District Road No. 1308 on the farm Zoekmakaar 778 – LS.

[Bandelierskop – Morebeng (Soekmekaar)]

(II) Description of existing proclaimed Provincial District Road 1308 between the junction with Provincial Road P54-1 and the junction with Provincial Road P43-2

The Section of Route R36, also known as Provincial District Road No. 1308, as previously declared by Administration Notices as Provincial District Road, continuing from the junction with Provincial Road P54-1 on the farm Zoekmakaar 778 - LS there from on proceeding in a general South-Easterly direction on existing Provincial District Road 1308 up to a point opposite the railway line Northern reserve North of Morebeng (Soekmekaar) Township where it terminates.

Again commencing South of Morebeng (Soekmekaar) Township at the intersection with Smit Street, there from on proceeding in a general South-Easterly direction on existing Provincial District Road No. 1308 up to the junction with Provincial Road P43-2 on the farm Goedgedacht 382 – LT.

(III) Description of existing proclaimed Provincial Road P43-2 between the junction with Provincial District Road No. 1308 and the junction with Provincial Road P17-2

The Section of Route R36, also known as Provincial Road P43-2, as previously declared by Administrative Notices as Provincial Road, continuing from the junction with Provincial District Road No. 1308 on the farm Goedgedacht 382 – LT, there from on proceeding in a general South-Easterly direction on existing Provincial Road P43-2, where it terminates North of Duiwelskloof Township at a point in line with the cadastral boundary between farms Vrystaat 437 – LT and Duivelskloof Township.

Again commencing South of Duiwelskloof Township at a point in line with the cadastral boundary between Portion 24 and Portion 17 of the Farm Schraalhans 450 - LT, there from on proceeding in a general Southerly direction on existing Provincial Road P43-2 up to a point where it joins Provincial Road P17-2 on the farm Tzaneen 538 – LT.

(IV) Description of existing proclaimed Provincial Road P17-3 between the junction with Provincial Road P43-2 and the junction with Provincial Road P43-3

The Section of Route R36, also known as Provincial Road P17-3, as previously declared by Administration Notices as Provincial Road, continuing from the junction with Provincial Road P43-2 on the farm Tzaneen 538 – LT, there from on proceeding in a general Southerly direction on existing Provincial Road P17-3 up to the junction with Provincial Road P43-3 on the farm Pusela 555 – LT Portion 23.

(V) Description of existing proclaimed Provincial Road P43-3 between the junction with Provincial Road P17-3 and the junction with Provincial Road P112-2

The Section of Route R71, also known as Provincial Road P43-3, as previously declared by Administrative Notices as Provincial Road, continuing from the junction with Provincial Road P17-3 on the farm Pusela 555 – LT Portion 23, there from on proceeding in a general Easterly direction on existing Provincial Road P43-3, through Tzaneen Township up to the junction with Provincial Road P112-2 on the farm Languedoc 563 - LT.

(VI) Description of existing proclaimed Provincial Road P112-2 between the junction with Provincial Road P43-3 and the junction with Provincial Road P17-3

The Section of Route R71, also known as Provincial Road P112-2, as previously declared by Administration Notices as Provincial Road, continuing from the junction with Provincial Road P43-3 on the farm Languedoc 563 - LT, there from on proceeding in a general South-Easterly direction on existing Provincial Road P112-2 up to the junction with Provincial Road P17-3 on the farm Farrell 781 – LT at Gravelotte Township.

(VII) Description of existing proclaimed Provincial Road P17-3 between the junction with Provincial Road P112-2 and the junction with Provincial Road P17-4

The Section of Route R526, also known as Provincial Road P17-3, as previously declared by Administration Notices as Provincial Road, continuing from the junction with Provincial Road P112-2 on the farm Farrell 781 – LT at Gravelotte Township, ther from on proceeding in a general South-Easterly direction on existing Provincial Road P17-3, through Gravelotte Township up to the junction with Provincial Road P17-4 at the Olifants River (the common boundary between the farms Excellence 157 – KT and Oxford 183 – KT).

(VIII) Description of existing proclaimed Provincial Road P17-4 between the junction with Provincial Road P17-3 and the junction with Provincial Road P17-5

The Section of Route R40, also known as Provincial Road P17-4, as previously declared by Administration Notices as Provincial Road, continuing from the junction with Provincial Road P17-3 at the Olifants River (the common boundary between the farm Excellence 157 – KT and the farm Oxford 183 – KT), there from on proceeding in a general Southerly direction on existing Provincial Road P17-4 up to the junction with Provincial Road P17-5 on the farm Fleur De Lys 194 – KU.

[Olifants River – Klaserie]

(IX) Description of existing proclaimed Provincial Road P17-5 between the junction with Provincial Road P17-4 and Limpopo/Mpumalanga Provincial Border

The Section of Route R40, also known as Provincial Road P17-5, as previously declared by Administration Notices as Provincial Road, continuing from the junction with Provincial Road P17-4 on the farm Fleur De Lys 194 – KU, there from on proceeding in a general Southerly direction on existing Provincial Road P17-5, up to a point just North of Acornhoek Township on the farm Greenvalley 213 – KU, right opposite the fenced boundary of Acornhoek SAPS, where it terminates.

Again commencing on a point South of Acornhoek Township on the farm Greenvalley 213 – KU, at the junction with Provincial District Road 3939, there from on proceeding in a general Southerly direction on existing Provincial Road P17-5, up to a point opposite the common boundary between Remainder Portion 5 and the Remainder of farm Maviljan 252 – KU at Bosbokrand Township where it terminates.

Again commencing from a point on the farm Maviljan 252 – KU opposite the Metro Cash and Curry business development at Bosbokrand Township, there from on proceeding in a general Southerly direction on existing Provincial Road P17-5, up to the Southern abutment of the Marite River bridge no. B1703 at the Limpopo/Mpumalanga Provincial Border on the farm Marite 287 - KU, where it terminates.
