

ANNEXURE**I) Description of existing proclaimed Provincial Road P16 -1 between Limpopo/ North West Provincial Border and the junction with Provincial District Road No. 336**

The Section of Route R510, also known as Provincial Road P16-2, as previously declared by Administrative Notices as Provincial Road, commencing from its intersection with the Limpopo/North West Provincial Border on the farm Nooitgedacht 11 – JQ, there from proceeding in a general Northerly direction on existing Provincial Road P16-2, through Northam Township, up to the Southern abutment of the Rooikulspruit bridge South of Thabazimbi Township on the farm Wachteenbietjesdraai 350 – KQ, where it terminates.

Again commencing North of Thabazimbi Township from a point in line with the common cadastral boundary between Portion 9 of the farm Rosseauspoort 319 - KQ and the Remainder of the farm Apiesdoorn 316 - KQ, there from on proceeding in a general Northerly direction on existing Provincial Road P16-2, up to the junction with Provincial District Road No. 336 on the farm Vaalpenspan 90 – KQ.

II) Description of existing proclaimed Provincial District Road No. 336 between the junction with Provincial Road P16-2 and the junction with Provincial Road P84-1

The Section of Route R510, also known as Provincial District Road No. 336, as previously declared by Administration Notices as Provincial District Road, continuing from the junction with Provincial Road P16 -2 on the farm Vaalpenspan 90 – KQ, there from on proceeding in a general Northerly direction on existing Provincial District Road 336 up to the junction with Provincial Road P84-1, also known as the R510, on the farm Hartbeestdrift 198 – KQ.

[Vaalpenspan – Hartbeestdrift]

III) Description of existing proclaimed Provincial Road P84-1 between the junction with Provincial District Road No. 336 and Monte Christo.

The Section of Route R510, also known as Provincial Road P84-1, as previously declared by Administrative Notices as Provincial Road, continuing from the junction with Provincial District Road No. 336 on the farm Hartbeestdrift 198 – KQ, there from on proceeding in a general North-Westerly direction on existing Provincial Road P84-1 up to the Junction with Provincial Road R33, also known as Provincial Road P198-1, on the farm Schaapplaats 524- LQ South of Lephalale Township, where it terminates.

Again commencing from the junction with Provincial Road R518 North of Lephalale Township on the farm Grootfontein 501 - LQ, there from on proceeding in a general Northerly direction on existing Provincial Road P84-1 up to the junction with Provincial Road R572, also known as Provincial District Road No. 887, on the farm Windhoek 127 – LQ at Monte Christo Township, where it terminates.
