Mabandla, hereby invites interested parties to nominate can didates for appointment by the President *to* the Commission on Gender Equality. Candidates must be South African citizens who are fit and proper persons for appointment and broadly representative of the South African community.

The above members of the Commission will be appointed by the President on the recommendation of the National Assembly of Parliament on a full-time and part-time basis and shall in both cases hold office for the unexpired period of the term of office ir respect of the vacancies, namely until 19 April 2006.
