### BOARD NOTICE 121 OF 2004

This Board Notice is effective as from 1 April 2005

#### SCHEDULE

1. In this Schedule any expression or word bears the meaning assigned to it in the Natural Scientific Professions Act, 2003 (Act 27 of 2003) and unless the context otherwise indicates -
2. **"the Act"** means the Natural Scientific Professions Act, 2003 (Act 27 of 2003).
3. **"the year"** means the period commencing on 1 April of any year and ending on 31 March of the next succeeding year.
4. **"annual fee"** means the fee payable by the registered member -
  - (i) within 30 days from the date on which he/she is informed of his/her registration in terms of Section II of the Act and thereafter
  - (ii) annually on or before 30 April;
5. **"registration fee"** means the fee payable when a person applied for registration in terms of Section II of the Act.

#### 2. FEES

- (a) Registration fees:
  - (i) Professional Natural Scientist : **R550,00 (VAT inclusive)**.  
Provided that a registration fee is payable for each category for which registration is requested and provided further that if an application or registration is not successful no fee shall be refunded to the applicant.
  - (ii) Candidate Natural Scientist: **R300,00 (VAT inclusive)**.  
Provided that a registration fee is payable for each category for which registration is requested and provided further that if an application for registration is not successful no fee shall be refunded to the applicant.
  - (iii) Certificated Natural Scientist: **R360,00 (VAT inclusive)**.  
Provided that a registration fee is payable for each category for which registration is requested and provided further that if an application for registration is not successful no fee shall be refunded to the applicant.
  - (iii) Upgrading of registration status: Candidate Natural Scientist to Professional Natural Scientist: **R550,00 (VAT inclusive)**.
  - (iv) Re-instating after lapse of registration:  
Professional Natural Scientist: **R550,00 (VAT inclusive)**  
Candidate Natural Scientist: **R300,00 (VAT inclusive)**  
Certificated Natural Scientist: **R360,00 (VAT inclusive)**

Provided that a registration fee is payable for each category for which re-instatement is requested.

- (b) Annual fees:  
**(NO ANNUAL FEES PAYABLE IN THE FIRST YEAR OF REGISTRATION)**
- (i) Professional Natural Scientist : **R480,00 (VAT inclusive).**
  - (ii) Candidate Natural Scientist: **R200,00 (VAT inclusive).**  
Provided that **if he/she** has been registered as a Candidate Natural Scientist for a period in excess of four years, the fee shall be **R480,00 (VAT inclusive).**
  - (iii) Certificated Natural Scientist: **R320,00 (VAT inclusive).**
  - (iv) Upgrading of registration status: Candidate Natural Scientist to Professional Natural Scientist: **None.**
  - (v) Re-instating after lapse of registration: Professional Natural Scientist/Candidate Natural Scientist and Certificated Natural Scientist: **None.**
  - (vi) Pensioner: (all levels of registration): **R110,00 (VAT inclusive).**
- (c) **No annual fees** will be payable in the **first** year of registration by:
- (i) Professional Natural Scientist, Candidate Natural Scientist and Certificated Natural Scientist.
  - (ii) Applicants upgrading their registration status from Candidate Natural Scientist.
  - (iii) Applicants re-instating their registration (all levels of registration).
