IMMIGRATION ACT, 2002

REGULATIONS ON FEES

The Minister of Home Affairs intends, in terms of section 7(1)(h) and (*i*) of the Immigration Act, 2002 (Act **No.** 13 of 2002), as amended by the Immigration Amendment Act, 2004 (Act **No.** 19 of 2004), after consultation with the Immigration Advisory Board and with the concurrence of the Minister of Finance, to make the regulations in the Schedule.

Interested persons are invited to submit any substantiated comments or representations on the proposed regulations to the Director-General: Home Affairs, Private Bag X114, Pretoria, 0001, within 21 days of the date of publication of this notice.

SCHEDULE

Fees for overtime services performed by immigration officer

1. Whenever a person calls at a port of entry for the purpose of admission to or departure from the Republic outside the official hours of that port of entry, he or she shall, in terms of section 7(1)(h) of the Act, pay the following overtime fees, as the case may be, per person:

- (a) R200 for each hour or part thereof in respect of each immigration officer who has to render such overtime services to that person: Provided that such person has beforehand, during the official hours of that port of entry, informed the immigration officer in control of that port of entry of the date and time of the intended call at that port of entry: Provided further that he or she calls at that port of entry within the hours and on the date so arranged; or
- (b) R400 for each hour or part thereof in respect of each immigration officer who has to render overtime services in all other cases to that person.
