PROCLAMATION

by the

President of the Republic of South Africa

No. R. *8, 2005*

SALARIES AND ALLOWANCES PAYABLE TO TRADITIONAL LEADERS, MEMBERS OF THE NATIONAL HOUSE OF TRADITIONAL LEADERS AND MEMBERS OF THE PROVINCIAL HOUSE OF TRADITIONAL LEADERS FOR 2004/2005 FINANCIAL YEAR

In terms of section 5 (1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998), I hereby-

- (a) (i) after consultation with the Premiers concerned; and
 - (ii) after taking into consideration the matters listed in paragraphs (a) to (h) of section 5 (1) of that Act; and
 - (iii) for the 2004/2005 financial year:
- (b) determine that:
 - (i) traditional leaders shall be entitled to the salaries as set out in the schedule;
 - (ii) members of the National House of Traditional Leaders shall, in addition to their salaries as traditional leaders, be entitled to an allowance in respect of actual meetings of the National House of Traditional Leaders, or a committee thereof, and seminars, workshops and conferences attended on behalf of the National House of Traditional Leaders, as set out in the Schedule; and
 - (iii) members of a Provincial House of Traditional Leaders shall, in addition to their salaries as traditional leaders, be entitled to an allowance in respect of actual meetings of the Provincial House of Traditional Leaders, or a committee thereof, and seminars, workshops and conferences attended on behalf of the Provincial House of Traditional Leaders, as set out in the Schedule.
