#### SKILLS DEVELOPMET ACT, 1998 (ACT NO. 97 OF 1998)

(Read with Government Notice No. R.1082 of 7 September 1999 as amended)

#### EXTENSION OF EXISTING PERIOD OF ESTABLISHMENT OF SECTOR EDUCATION AND TRAINING AUTHORITIES (SETAS)

I, Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, after consultation with the National **Skills** Authority, has, under section 9(1) of the **Skills** Development Act, 1998 (Act No. 97 of 1998) as amended, read with Regulations regarding establishment of Sector Education and Training Authorities (**SETAs**) as contained in Government Notice No. R.1082 of 7 September 1999 as amended, extended the period of establishment of **SETAs** in schedule 1 hereunder, from 20 March 2005 to 31 March 2005. The period of establishment of SETAs in schedule 2 is extended from 20 March 2005 to 30 June 2005.
