THE SOUTH AFRICAN NATIONAL ROADS AGENCY LIMITED**DECLARATION OF EXISTING PROVINCIAL ROADS - (I) PROVINCIAL ROAD P33 SECTION 2, (II) PROVINCIAL ROAD P33 SECTION 3, (III) PROVINCIAL ROAD P9 SECTION 2 AS NATIONAL ROAD R37- DISTRICTS OF LYDENBURG, PELGRIMS REST 2 AND NELSPRUIT.**

By virtue of Section 40(1)(a) of the South African National Roads Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) the Section of Provincial Road P33 Section 2, also known as R37 commencing from the Limpopo/Mpumalanga Provincial Border up to Lydenburg, (II) the Section of Provincial Road P33 Section 3, also known as R37, from Lydenburg up to the junction with Provincial Road P9 Section 2, and (III) the Section of Provincial Road P9 Section 2, also known as R37, continuing from the junction with Provincial Road P33 Section 3 up to the junction with Provincial Road R17 Section 7, as described in the Annexure hereto to be a National Road.

ANNEXURE**(i) Description of existing proclaimed Provincial Road P33-2 between the Limpopo/Mpumalanga Provincial Border and the junction with Provincial Road P8-2.**

The Section of Route R37, also known as Provincial Road P33-2, as previously declared by Administrator Notices as Provincial Road, commencing from the intersection with the Limpopo/Mpumalanga Provincial Border on the farm *Leeuwallei 297 - KT*, where it joins the existing National Road R37 as declared by Government Notice No. 887 of 30 July 2004, there from on proceeding in a general South-Easterly direction on existing Provincial Road P33-2 up to the junction with Provincial Road R555, North of Burgersfort, where it terminates. Again commencing from a point on the Northern abutment of the Tshipapodi Spruit bridge, South of Burgersfort, there from on proceeding in a general South-Easterly direction on existing provincial Road P33-2 up to the junction with Provincial Road P8-2, also known as the R36, on the farm Townlands of Lydenburg 31- JT, North of Lydenburg, where it terminates.

(ii) Description of existing Provincial Road P33-3 between Lydenburg and the junction with Provincial Road P9-2.

The Section of Route R37, also known as Provincial Road P33-3, as previously declared by Administrator Notices as Provincial Road, again commencing from a point in line with the Eastern boundary of Van Der Reyden Street, East of Lydenburg, there from on proceeding in a general South-Easterly direction on existing Provincial Road P33-3 up to the junction with Provincial Road P9-2 on the farm Olifantsgeraamte 198 - JT.

[Lydenburg - Klein Spitskop (Sabie)]

(iii) Description of existing Provincial Road P9-2 between the junction with Provincial Road P33-3 and the junction with Provincial Road P17-7.

The Section of Route R37, also known as Provincial Road P9-2, as previously declared by Administrator Notices as Provincial Road, continuing from the junction with Provincial Road P33-3 on the farm Olifantsgeraamte 198 - JT, there from on proceeding in a general South-Easterly direction on existing Provincial Road P9-2 up to the junction with Provincial Road P17-7, also known as the R40 on the farm Boschrand 283 - JT, North of Ngodwana (Nelspruit), where it terminates.
