By virtue of section 40(1)(a) of The South African National Roads Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) he Section of Provincial Road P4 Section 2 also known as N18, commencing from the North West/Northern Cape Provincial Border, up to Huhudi (Vryburg), (II) the Section of Provincial Road P71 Section 8 also known as N18, from Huhudi (Vryburg) up to where it joins Provincial Road 71 Section 9, (11) the Section of Provincial Road P71 Section 9, also known as N18, continuing from where it joins Provincial Road P71 Section 9, also known as N18, continuing from where it joins Provincial Road P71 Section 5, also known as N18 continuing from Mothabeng (Mafikeng) to the Ramatlabama Border Post as described in the Annexure hereto, as a National Road.

## (I) Description of existing proclaimed Provincial Road P4-2 between the North West/Northern Cape Provincial Border and Huhudi (Vryburg).

The Section of Route N18, also known as Provincial Road P4-2 as previously declared by Administrative Notices as Provincial Road, commencing from the intersection with the North West/Northern Cape Provincial Border also the Northern boundary of Vaalharts Settlement, there from on proceeding in a general North-Westerly directing on the existing Provincial Road P4-2 up to a point in line with the Southern boundary of South Street south of Huhudi (Vryburg), where it terminates.

## (II) Description of existing proclaimed Provincial Road P71-8 between Huhudi (Vryburg) to where it joins e junction with Provincial Road P71-9.

The Section of Route N18, also known as Provincial Road P71-8 as previously declared by Administrative Notices as Provincial Road, again commencing from a point in line with south western boundary of Portion 31 of the farm Vlakfontein 675 north of Huhudi (Vryburg), there from on proceeding in a general North-Easterly direction on the existing Provincial Road P71-8 up to where it joins Provincial Road P71-9 on the farm Biesjes Bult **549**

## (111) Description of existing proclaimed Provincial Road P71-9 from where it joins Provincial Road P71-8 and Motlhabeng (Mafikeng).

The Section of Route N18, also known as Provincial Road P71-9 *as* previously declared by Administrative Notices as Provincial Road, continuing from where it joins Provincial Road P71-8 on the Farm Biesjes Bult 549, there from on proceeding in a general North-Easterly directing on the existing Provincial Road P71-9 up to point in line with the northern abutment *of* the Lotlhakane River Bridge south west of Motlhabeng (Mafikeng), where it terminates.

# (IV) Description of existing proclaimed Provincial Road P28-5 between Motlhabeng (Mafikeng) and Ramatlabama Border post.

The Section of Route N18, also known as Provincial Road P28-1 as previously declared by Administrative Notices as Provincial Road, again commencing from a point in line with the northern boundary of MMabatho Town and Townlands 301 – JO. there from on proceeding in a general Northerly direction on the existing Provincial Road P28-5 up to the entrance of the Ramatlabama Border Post operational area on Portion 1 of the farm Ramatlabama no. 377, at the North West/Botswana International Boundary, where it terminates.
