LABOUR RELATIONS ACT, 1995

ESTABLISHMENT OF STATUTORY COUNCIL

1, Johannes Theodorus Crouse, Registrar of Labour Relations, hereby, in terms of section **40(1)** of the Labour Relations Act, 1995, establish the Statutory Council for the Squid and Related Fisheries of South Africa.

Character of sector:

The sector is defined as follows:

Squid fishing by means of handline jigging method from fishing vessels at sea

Which include -

- The maintenance personnel who are responsible for keeping the vessels and ancillary equipment in a sea going and serviceable condition
- The administrative (office) personnel who are responsible for the administrative function (the paper work) that inevitably goes with the employment of personnel; and

The factory based personnel who are responsible for the handling of the Squid on land in the land.

Area:

Eastern Cape and Western Cape Province
