APPLICATION FOR THE AMENDMENT OF LICENCE CONDITIONS: CAPE TALK (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of section 52(2)(a) of the Independent Broadcasting Authority Act, Act No 153 of 1993 ("the Act"), that it has received an application from Cape Talk (Pty) Ltd for the amendment of its broadcasting licence in terms of section 52(1)(c) of the Act. The amendment is sought to enable the Cape Talk (Pty) Ltd to amend its shareholding structure as set out in the schedule mentioned below.
2. The application is available for inspection by any interested parties during the Authority's normal office hours.
3. Interested persons are hereby invited to make written representations on the proposed amendment to the Authority by 30 September 2005.
4. Cape Talk (Pty) Ltd shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and any such written response must be submitted to the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Cape Talk (Pty) Ltd must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.

SCHEDULE

1. According to the applicant, the proposed amendment will result in a change to paragraph 1 of Schedule C of its shareholding structure, which is currently as follows:
 - 1.1 Primedia Broadcasting (Pty) Limited ("Primedia Broadcasting") holds **43.75%** of all the issued shares in Cape Talk (Pty) Limited ("Cape Talk");
 - 1.2 The Mineworkers Investment Company (Pty) Limited ("MIC") holds 56.25% of all the issued shares in Cape Talk (Pty) Limited ("Cape Talk").
2. Primedia Limited and the Mineworkers Investment Company (Pty) Ltd ("MIC") have entered into an agreement in terms of which Primedia Broadcasting (Pty) Limited is to acquire all of the Mineworkers Investment Company (Pty) Limited's ("MIC's") shares in Cape Talk, subject to various suspensive conditions, including, that all the necessary regulatory approvals be obtained.
3. The acquisition of the Mineworkers Investment Company (Pty) Limited's shares by Primedia Broadcasting (Pty) Limited will necessitate an amendment to Schedule C to Cape Talk's licence such that paragraph 1 of Schedule C of Cape Talk's licence is to read as follows:
 - "1.1 Primedia Broadcasting (Pty) Limited holds **100%**".
