SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)

1. APPLICANT: Baron Jean-Yves de Sainte-Croix de la Sabliere (H4/3/4/767)

BANNER: Tierced in pairle Sable, Gules and Azure, a fillet pall Or, between in chief a fleur-de-lis Or, dexter a Maltese cross Argent and sinister a lion rampant Or, armed and langued Gules; in base two swords in saltire Argent, fringed alternately Or and Azure.

2. **APPLICANT:** Baron Jean-Yves de Sainte-Croix de la Sabliere (H4/3/4/767)

BADGE: On a hurt, edged Or, a plume of three ostrich feathers Argent, enfiled by a coronet of the first, embellished with four fleurs-de-lis of the second and entwined by a string of pearls bendwise proper.

3. APPLICANT: Baron Jean-Yves de Sainte-Croix de la Sabliere (H4/3/4/767)

STANDARD: In the hoist the arms of Mario Baron Jean-Yves de Sainte-Croix de la Sabliere and in the fly (the end bifurcated), tierced per fess Sable, Gules and Azure, the Gules section edged Argent, between two transverse bends Or, edged Argent, bearing the motto PER CRUCEM TRIUMPHANS in letters Sable, in the first compartment a lion rampant Or, in the second compartment a Maltese cross Argent, and in the third compartment two swords in saltire Argent charged with a plume of three ostrich feathers Argent, enfiled by a coronet of the first, embellished with four fleurs-de-lis of the second and entwined by a string of pearls bendwise proper; the sleeve Azure, fringed compony Or and Azure.

4. APPLICANT: Justin Cleve de Beauharnais Swanstrom (H4/3/4/797)

ARMS: Azure, two bars wavy Argent, between three swans rising, wings elevated and addorsed of the second, beaked and membered Or, placed two and one.

6. APPLICANT: Martin Reeves (H4/3/4/829)

ARMS: Azure, on a chevron Argent, three lozenges Gules, between in chief two lions rampant respectant, each clasping with both claws a sword erect, and in base a chained portcullis, all Or.

CREST: A fish eagle risant proper.

WREATH AND MANTLING: Azure and Argent.

MOTTO: HONOR ANTE GLORIA

ARMS: Azure, issuant from the peak of a trimount Gules, three ears of corn Or, on a chief Azure, three fleurs-de-lis Or, ensigned of a label of four points Gules.
