Government Notice No. R 871 of published in Government Gazette No. 27999 of 02 September 2005, is hereby corrected as follows:

In the English text:

Substitute the expression "01 July 2005" for the expression "01 January 2006", where it appears in paragraph **8** (e) *on* page 7.

Substitute the expression "...shall be have.,." for the expression "...shall have...", where it appears in paragraph 12 (b) on page 9.

Substitute the expression 'Doors of minibuses ..." for the expression 'Passenger entrance **doors...**", where it appears in paragraph 13 (c) on page 11.

Substitute the number "14 (1)" for the number "14(2)" where it appears in paragraph 14 on page 11.

Substitute the expression '...on or after 1 Juty 2006..."for the expression 'on or after 1 January 2006..."where it appears in paragraph 15 (2) on page 11.

Substitute the expression "...after 01 January 2006, operating..." for the expression "...after 01 January 2006, and operating...", where it appears in paragraph 15 (6) on page 12.

Substitute the expression "...,an integral headset, top..." for the expression "...an integral headset, the top..."where it appears in paragraph 15 (6) (ii) on page **13**.

Substitute the expression "one *front seats*" *for the* expression "one front seat" where it appears in paragraph **15** (6)(j) on page 13.

Substitute paragraph 16 (1) for the following: 'no person shall operate any midibus or single deck **bus** first registered after 01 January 2006, and operating licence issued *in* 

accordance with the NLTTA on a public road unless such midibus or single deck bus is capable of being tilted sideways to an angle of at least 28 degrees in either direction from the upright position without overturning" where it appears in paragraph 16 (1) on page 14.

Substitute the expression "minibus" for the expression "midibus" where 'it appears in paragraph 16(1) on page 14.

Substitute the expression "01 July 2005" for the expression "01 January 2005" where it appears in paragraph 17 (1) on page 14.

Where the expression "issued in terms of operating license in accordance with the NLTTA (National Land Transport Transition Act) " appears it should be noted that reference is made to mean "minibus taxi-type service".
