REGULATIONS RELATING TO THE **REGISTRATION** OF **FERTILIZERS,** FARM FEEDS, AGRICULTURAL REMEDIES, STOCK REMEDIES, **STERILIZING** PLANTS *AND* PEST **CONTROL OPERATORS, APPEALS AND IMPORTS: PROPOSED** AMENDMENT

I, Angela Thokozile Didiza, Minister of Agriculture, acting under section 23(4) of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act No. 36 of 1947), has made the regulation set out in the Schedule as from April 2005.
