#### APPLICATION FOR THE RENEWAL OF A FOUR YEAR COMMUNITY SOUND BROADCASTING LICENCE: KARMA COMMUNITY PROJECTS

The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section **44(2)** of the Independent Broadcasting Authority Act, No 153 of 1993, **as amended**, that it has received an application from Karma Community Projects, broadcasting as Eastwave Radio, for the renewal of its community sound broadcasting licence in terms of section **44(1)**.
