## ESTABLISHMENT OF A MINISTERIAL COMMITTEE ON LITERACY

I, Grace Naledi Mandisa Pandor, Minister of Education, in terms of section 20.2 and 20.3 of the Public Finance Management Act, 1999: hereby establishes a Ministerial Committee on Literacy.

#### TERMS OF REFERENCE

- 1. The functions of the committee will include the following:
  - a. To advance cordial relations that South Africa has with Cuba, to consider the Cuban Literacy Model and to learn from the remarkable success that Cuba achieved in literacy;
  - b. To investigate the nature, character and content of the Cuban model, particularly when translated and practised in other countries, such as Venezuela and New Zealand:
  - c. Investigate the nature, character and content of other mass literacy models that committee members may be familiar with; (a desktop research conducted by the compiler has also shown strong similarities between the National Literacy Mission (NLM), a literacy campaign launched in India in 1983, the Alfa Sol programme launched in Brazil in 1995 and the SANLI programme)
  - d. To locate this review and recommendations emanating out of it within the context of what has been tried and done in South Africa (relating to both successes) e.g. what could be learned from the SANLI process?
  - e. To present a proposal for access to Mass Literacy in South Africa, utilising social mobilisation or a national call to action of a broad range of partners and communities;
  - f. Develop **an** implementation plan with an indication of the targets to be achieved, the implementing partners and the institutional driver or drivers to the process;
  - **g.** Recommend appropriate and reasonable systems, programmes and resources that would be required to implement the (adapted) model in our country; and
  - h. To recommend proposals for monitoring and evaluation of progress.
- 2. As part of its brief, members of the Ministerial Committee would conduct study tours of Cuba, Venezuela and New Zealand to learn first hand about the implementation of the model in these contexts.
