**NOTIFICATION BY PRESIDENT IN RESPECT OF ENTITIES IDENTIFIED
BY THE UNITED NATIONS SECURITY COUNCIL: SECTION 25 OF THE
PROTECTION OF CONSTITUTIONAL DEMOCRACY AGAINST
TERRORIST AND RELATED ACTIVITIES ACT, 2004**

I, Thabo Mvuyelwa Mbeki, *President of the Republic of South Africa*, hereby, in terms of section 25 of the *Protection of Constitutional Democracy against Terrorist and Related Activities Act, 2004 (Act No. 33 of 2004)*, give notice that the Security Council of the United Nations, under Chapter VII of the Charter of the United Nations, has identified the entities mentioned in the Annexure, as being-

- (a) entities that commit, or attempt to commit, any terrorist and related activity or participate in or facilitate the commission of any terrorist and related activity; or

(b) entities against whom Member States of the United Nations must take the actions specified in the Resolutions of the said Security Council, in order to combat or prevent terrorist and related activities.





NOTICE IN TERMS OF ITEM 11(1)(a) OF SCHEDULE 1 TO THE FIREARMS CONTROL ACT, 2000 (ACT NO. 60 OF 2000)

I, Charles Nqakula, Minister for Safety and Security, hereby **determine**, in terms of item 11(1)(a) of Schedule 1 to the Firearms Control Act, 2000 (Act No. 60 of 2000), that the period within which a natural person who is the holder of a licence issued in terms of the Arms and Ammunition Act, 1969 (Act No. 75 of 1969), and who must **apply for** a corresponding licence in terms of the Firearms Control Act, 2000, as determined in paragraph 1(a) of Government Notice No. R. 974, dated 20th of August 2004, be amended by substituting in the renewal period the date 31 December with **31 March** of each of the successive years from 2007 to 2009.

NOTE: The date of 31 December 2005, determined in the above Notice, has already been extended until 31 March 2006, in Government Notice No. R. 1248 of 21 December 2005.
